President's Report:

<u>Wendy Westock</u>: Board Positions open – letters of interest due by 5:00 p.m. on Friday, November 2. Interviews will be held the following week.

- Security we now have 2 full time guards, Baylee and Kim, who are exclusively assigned to Sunrise giving us 80 hours a week of coverage.
- Real Estate -33 houses, 9 more pending and 2 lots have sold in Sunrise since June 1 (that is a 50% increase from last year)
- Thank You Kris Frillman for doing the black signs announcing upcoming events, to Gloria Nolan for agreeing to be the resident chair of the Communications Committee and to Nicole Hammer for agreeing to be the resident chair of the Events Committee.
- Perk Test as we anticipate further discussions about the future direction of our community one of the critical pieces of information we need is what are possible

locations for amenities.

- The ball field is the most logical location, but we do not know if it is a buildable lot as it has not been perked, therefore, the board has decided to have the property perked. This will hopefully happen before winter sets in.
- -FYI 79% of residents are full-time and 21% are part-time.
- -Insurance premium increase of 4.3% most of which is in workman's comp.

Rule 3.18

(Old Rule)

<u>Winter Parking Restrictions</u>: "To permit snow removal, property owners, guests or tenants are not permitted to park any vehicle on community roads and easements from November 15th to April 1st. Violations will be subject to a \$100.00 fine and the vehicle will be towed at the owners expense. (Old Rule #20)"

(New Rule)

<u>Winter Parking Restrictions</u>: property owners, guests or tenants are not permitted to park any vehicle on community roads and/or easements (Easement is 5ft. from edge of road) from November 15th to April 1st. (Old Rule #20)

- a. First offense is subject to a \$25.00. fine
- b. Second offense is subject to a \$50.00 fine
- c. Subsequent offenses are subject to a \$75.00 fine per occurrence

<u>Chip Dingman</u> - Residents are responsible for removing trees/debris from their property.

<u>Aly Wayne</u> - Why does the ignition coil in the mason dump need to be replaced already?

Amy Panetta - The ignition coil went, it is an older truck, 2012.

Brendan O'Sullivan - Did we charge for dumpster day?

Wendy Westock - No

<u>Caryn Dingman</u> - might be a good idea to let residents know now that there will most likely be a nominal fee for dumpster day next year.

Questions from the Residents

Brendan O'Sullivan - Article in the Dispatch regarding Section 9.

<u>Amy Panetta</u> - reads the response given to the SLPOA Board by Jim Ott. Wendy clarifies that the SLPOA has no liability regarding the article.

Brendan O'Sullivan - inquires about the lawsuit regarding the sections.

Amy Panetta - indicates the lawsuit is still ongoing.

<u>Brendan O'Sullivan</u> - Mentions that a house on Rabbit Run has recently sold for \$300,000+.

<u>Board</u> - Discussion amongst the Board regarding the rising values of homes in Sunrise Lake.

<u>Brendan O'Sullivan</u> - would like for the part-time residents to be identified so that our full time residents can possibly watch over their homes, take out their garbage, etc. Also would like to see teenage volunteers to help out the residents of the community with odd jobs. Would like the office to keep a list of those volunteers that can be shared with residents.

<u>Wendy Westock</u> - would like to figure out a way to get the teenagers involved to assist in shoveling snow, odd jobs, etc. If someone would volunteer to lead this initiative/form a committee. Discussion regarding reaching to the school to see which extra-curricular activities require volunteer hours for students.

<u>Diane Meyerhoff</u> - discusses various homes in the community that would be considered eyesores. Is there anything that the community/board can do to urge the residents to clean their property? For example, if a Habitat for Humanity house can we reach to Habitat for Humanity to ask them to assist us in getting the homeowners to clean the property. Also discusses residents that have multiple, non-registered cars in their driveways.

<u>Board</u>: Board members explain that warnings have been sent to residents for eyesores, as well as fines. Also, that security takes pictures of properties and documents "eyesore." Explains warning letters are sent and residents are given 30 days to clean the yard. Board also discusses the non-registered car situations and states that unless they pose an environmental threat, there is not much that can be done.

<u>Sophia Altvater</u> - asks if the 9/11 Memorial Garden can be cleaned up, trees trimmed.

<u>Amy Panetta</u> - indicates we will ask our maintenance personnel to take care of it.

<u>Arlene Matthews</u> - expresses her concern regarding a house across the street from her, where a previous owner buried the culvert pipe, which is now contributing to the deterioration of the road (Sunset)

Amy Panetta - We will have maintenance personnel look into the situation once Arlene sends us the house number.

Wendy Westock: asks for a motion to close the meeting at 8:20 pm.
