G. <u>Administrative Items</u>:

Meeting Discussion Items with Tricia Almiron, Legislative Representative, Kevin Jeffries office

Staff presented memorandums for the following items:

a. Airbnb's, Weddings, and Events

Ms. Susan Frommer presented an article about "Airbnb moves in" and what has happen in Venice. Ms. Frommer strongly suggested that Tenaja act before the District suffers the same fate as Venice.

The Board discussed the County Ordinance (submitted last month) concerning Airbnb's from the and the discussion with the Code Enforcement Officer.

The District is trying to schedule a meeting with LAFCO officials to discuss certain items such as the Airbnb's, weddings, and events. Discussion about Tenaja adopting an Ordinance that

restricts and fines property owners also took place. The excessive use of the roads for these parties and events is a concern. Until the second meeting with Tricia Almiron and LAFCO takes place, the District should not move forward.

All writing of Ordinances also need to go through legal counsel.

Furthermore, concerning events such as weddings, the District was told that an actual Code Enforcement Officer must be able to see the event, count "heads" – over 200 people at a party, and see advertisement concerning the party before they can act

b. Agricultural Permits

Staff reported that Tenaja has asked to be placed on the list for notifications.

c. Code Enforcement matters

A list of code violations was submitted. Staff was promised follow up by Ms. Almiron.

All of the other items have been submitted to Ms. Almiron also. Item g – gaining money from Gas Tax – was briefly discussed at the meeting and it was suggested that Ms. Melissa Melendez, Assemblywoman would be the best contact person to sponsor a bill in the assembly. The Board directed Staff to follow up on that matter with Ms. Melendez.
