Associate Membership: (Individual) **\$10.00**

This does not include voting privileges nor can you run for an officer position. You are not required to meet the requirements of attendance as required by General Membership.

Junior Membership: \$5.00

This is for those Juniors who meet AKC rules on age and to fully participate as a General Membership except there are no voting privileges nor can you participate for an officer position available until your age exceeds 18 years. At that time your membership will be transferred and you will be given the choice of either General or Associate Membership to be maintained if you so choose.
