

The primary goal of the District is the protection, improvement, and conservation of the county's soil, water, and related natural resources as well as educating the community in various conservation and environmental practices and methods.

The Conservation District coordinates educational events, completes conservation projects, and provides assistance to farmers, citizens, land owners, partner organizations, municipalities and more.

The Warren County Conservation District is a local conservation organization formed for the protection and promotion of wise use of land, water, and other natural resources. The District dates back to April 12, 1948 and is governed by a board of eight directors. District staff implement programs, conservation projects, and educational events in cooperation with a number of partnering agencies and organizations. In addition to the District, our building also houses the Natural Resources Conservation Service (NRCS), Penn Soil Resource Conservation and Development Council (Penn Soil RC&D) and Conewango Creek Watershed Association (CCWA). The Warren County Conservation District office is located in Warren, PA at the corner of Hatch Run Rd and Conewango Avenue.

# *Land Development and Permitting.*

## **Working in or near a stream**

**The PA Code: Title 25 Chapter 105 Program regulates work in and around streams, wetlands and other water bodies with a focus on avoiding or minimizing impacts to water quality, flooding frequency and riparian habitats.**

In most cases, a permit is required before starting any activity which changes, expands or diminishes the course, current or cross-section of a stream, floodway or body of water. The District acknowledges General Permits for various types of work in and around waterways. District staff will also conduct inspections of permitted sites, investigate complaints and provide technical, regulatory and permitting assistance.

### **Chapter 105 General Permits include:**

**GP01 - Fish Habitat Enhancement Structures**

**GP02 - Small Docks & Boat Launching Ramps**

**GP03 - Bank Rehabilitation, Bank Protection and Gravel Bar Removal**

**GP04 - Intake & Outfall Structures**

**GP05 - Utility Line Crossings**

**GP06 - Agricultural Crossings and Ramps**

**GP07 - Minor Road Crossings**

**GP08 - Temporary Stream Crossings**

**GP09 - Agricultural Activities**

**GP10 - Abandon Mine Reclamation**

**\*GP11 - Maintenance, Testing, Repair, Rehabilitation or Replacement of Water Obstructions and Encroachments**

**\*GP15 - Private Residential Construction of Wetlands**

**\*JP - Joint Permit for Water Obstructions and Encroachments**

**\* - Reviewed and approved by the DEP Northwest Regional Office**



## **Earth Disturbances**

**The PA Code: Title 25: Chapter 102 Erosion and Sediment (E&S) Control Plans, Permits, and NPDES Permits regulates Earth Disturbance Activities and Best Management Practices (BMP) of those activities.**

### **If your project's area of earth disturbance is:**

**A. Under 5,000 sq ft:** State Regulations note that these sites are still required to install, implement and maintain BMP's to minimize accelerated erosion and sedimentation.

**B. Over 5,000 sq ft - 1 acre (43,560 sq ft):** Requires a written E&S Plan to be reviewed and approved by the District. The approved plan should be available on site and implemented.

**C. 1 acre or more of earth disturbance:** Will require a National Pollutant Discharge Elimination System (NPDES) Permit.

- Individual NPDES - projects taking place in special protection watersheds will need an Individual Permit.
- General NPDES - all other projects that meet NPDES criteria but are not in a Special Protection Watershed.
- Also an approved, stamped, signed and dated COPY of the E&S plans must be kept on site for both Individual and General NPDES Permits.

### **D. Timber Harvest or Road Maintenance Activity:**

- Over 5,000 sq ft of earth disturbance will require an E&S Plan to be written and available on site. BMP's need to be installed, implemented and maintained just as above.
- 25 acres of earth disturbance or more will require an E&S PERMIT to be submitted to the District for review and approval.

**Before any earth disturbance activity can occur required permits and plans must be approved.**

**Projects requiring earth disturbance or occurring near a watercourse can be subject to the above guidelines and may require special permits and approvals. Check with the Conservation District before you begin your project to obtain accurate information as to what permits are needed.**


# *Dirt, Gravel, and Low Volume Roads Program*

## **Grant Applications are due November 6, 2020.**

Since the creation of the Dirt & Gravel Roads Program (DGR) in 1997, the Warren County Conservation District has funded the improvement of over a hundred work sites in various municipalities in Warren County, totaling over \$4.5 million spent on local roads. The goal of this program is to create a more environmentally and economically sustainable dirt & gravel roads network in the state of Pennsylvania through education, outreach and project funding.

In Pennsylvania, non-point source pollution is responsible for 88% of all impaired streams. The dust and sediment pollution resulting from the poor maintenance of the more than 27,000 miles of dirt and gravel roads in the Commonwealth has been shown to be a large contributor to this pollution.

Filling the road profile and adding cross pipes such as Sugar Grove Township did on Dump Road is an excellent way to improve drainage and reduce maintenance costs on dirt and grave roads.

## *The Secret Life of Soil*

Soil is complex. No, really; it is. Soil is more than the dirt under our fingernails. It contains an entire living, breathing ecosystem with food cycles, nutrient cycles, water cycles, and life cycles, and is literally the source of all food on the planet. When soil is not treated properly we end up with problems. The Dust Bowl of the 1930's is just one example. Dust was carried over 1800 miles from Colorado to parts of New England as a result of drought and poor farming practices. These dust particles in the air lead to pneumonia, lung infections, and death. As stewards of the earth we have a responsibility to care for the very thing we depend on so strongly.



If you have livestock of any sort on your property; be it one horse for riding, a pig your child is raising for a 4-H project, or chickens you're keeping for eggs, you have a unique opportunity to nourish your soil with the manure produced by your animals. Animal manure contains nutrients and minerals the soil (and micro-organisms living in it) can utilize to help plants grow, retain rain water, and reduce erosion.

Something that will help you achieve this healthy state of abundance is a Manure Management Plan. A Manure Management Plan will help you provide valuable fertilizer to growing crops and build the soil with organic matter. If you don't have a place to land apply the manure, a Manure Management Plan can also help make decisions as to how you might properly stack and store your manure, and maybe share it with a neighbor who has a use for it.

In addition to being a good idea, Manure Management Plans can help you save money. By knowing the nutrient contents of your soil and manure you'll be able to distribute the manure you have to the land that needs it the most. This will reduce the need for fertilizer, thereby saving you money. Properly managing your manure will also keep you in compliance with State regulations. State regulations are not difficult to meet and following a Manure Management Plan will go a long way to benefit the health of your animals, the health of your soil, and the general well-being of your operation.

**Application deadline for YCC is May 27th. Application deadline is June 24th for all KNC and CNC camps. (T-shirts are not ordered for late registrations.)** Space in each camp is limited so applicant selection will be on a first come, first serve basis.

All Warren County Conservation District Summer Camps are designed to foster an appreciation for the outdoors as kids discover the uniqueness and importance of plants and animals in our local environment through hands-on lessons, crafts, stories, games, presentations and demonstrations. **Children must be potty trained to participate in any of our programs.**

**Youth Conservation Camp (YCC)** is a twelve hour day camp running from **8am - 8pm** that focuses on the philosophy of Learning by Doing. The majority of the time is spent “in the field” where campers learn about trees and plants, soil, aquatics, ecology, wildlife, farming, and more. Representatives of the PA Fish and Boat Commission, the PA Game Commission, the PA Department of Environmental Protection, the Kalbfus Club, and others along with the Warren County Conservation District present several programs. Lunch and dinner will be provided Tuesday and Wednesday. Lunch will be provided on Thursday and parents will be asked to bring a dish to pass for the Thursday family picnic dinner. YCC is based out of the new Conservation District Building at the corner of Conewango Ave. and Hatch Run Rd. Parents are responsible for dropping off and picking up their children at the beginning and end of each day. YCC is limited to 20 kids. Cost for YCC is \$60 per child.

**Children's Nature Camp (CNC)** is geared towards elementary school students from 1st-6th grades and is broken up into three age groups. CNC I includes children entering 1st and 2nd grade, CNC II is for children entering 3rd and 4th grade, and CNC III is for 5th and 6th graders for the 20/21 school year. CNC will be held from **8am - 3pm** at the pavilion of the Hatch Run Conservation Demonstration Area on Hatch Run Road; a quarter mile past Penn DOT's Driver's License Center. A morning snack is provided but children must bring a packed lunch and a water bottle. Children will learn and discover the uniqueness and importance of plants and animals in our local environment. Each day, the campers will be introduced to new, memorable learning experiences through a variety of outdoor activities. Each CNC camp is limited to 25 kids. Cost for all CNC camps is \$40 per child.

**Kindergarten Nature Camp (KNC)** is for children going into Kindergarten this fall. The camp is based out of the pavilion of the Hatch Run Conservation Demonstration Area on Hatch Run Road; a quarter mile past Penn DOT's Driver's License Center. The camp will be held from **9am - 2pm**. This is a fun filled camp learning about water, plants, animals, and soil. There will be crafts, games, and exploring in nature. A morning snack and water will be provided. Children must bring a packed lunch and a water bottle. This camp will be limited to 10 kids so act fast! Cost for KNC is \$20 per child.

**Application Procedure:** Complete the attached application with the parental consent form in addition to the Responsibility Clause, Photo Release Form, and Emergency Medical Information (Pages 7 & 8). Please use separate forms for each child attending. 
## Envirothon
