## *The Al Moroccan Nation at Northwest Amexem Private Charter Trust*



Any transfers to the Declaration of Trust or any trust thereunder may refer to the aforesaid appellation or to "Adeyinka Kaylah Selestani Bey and any or all verified declared Nationals under our Al Moroccan Nation as Trustees under "The Al Moroccan Nation at Northwest Amexem Private Charter Trust dated November 11, 2020", with or without specifying any change in Trustee(s).


