#### Datum Petitionibus ( Granted Petitions/ Stare Decisis )

- 1. Friday (Wholyday) All Moors are to wear blac (white)
- 2. National Status (Nationality) = Al Moroccan / Al Muurican Moor / Mu'ur
- 3. Moors are to no longer refer to U.S/ currency as money or dollar; it is now to be referred to as a Note, FRNs (Federal Reserve Notes), Fiat, Security
- 4. Moors shall autograph all documents in red and/or purple ink and in the following format: Beneficiary

## All Rights Reserved and Retained / Without Prejudice

- 5. Domicile Privately as a Al Moroccan National Not a resident
- 6. dismissed terms:
  - Moorish American
  - Signature
  - Resident / Residence
- 7. Public venue dress code such as pseudo court events, pseudo town halls, political events, or events for the public Moors MUST wear royal headdress (fez and/or turban)
- 8. All defamation claims must me brought forth to the Al Moroccan Empire International Court as a violation claim for adjudication.
- 9. Moors are to no longer claim Constitutional Rights but to enforce Constitutional PROTECTED rights.
- 10. Moors are to establish bank accounts through the Bank of Atmaurium.
- 11. dismissed term Sovereign Citizen.
- 12. dismissed terms Black, Pay, Paid, Payment
- 13. dismissed the term understand
- 14. dismissed the terms kidnap and abducted and replaced with terms: unlawfully captured and/or seized.
