- **1.** Meeting Called to Order: President Nathan called the meeting to order at 12:04 p.m.
- **2. Approve the Agenda:** Motion to approve the November 14, 2021 Agenda made by Mike and seconded by Kati Motion approved.
- **3. Devotions:** Given by Kent for Elders. (Parish Ed. in December)
- **4. Opening Prayer:** Given by Pastor Paul.

- 5. Approve Minutes of Last Meeting: The October 10, 2021 Church Council Minutes, previously emailed, were read by council members. Motion to approve the October 10, 2021 meeting minutes made by Jim E. and seconded by Dale. Motion approved.
- **6.** Treasurer's Report: Given by Lonnie. Treasurer Notes October (Copies of the October Financial Report are available on the bulletin board near the office and on the table in an orange folder by the front entrance.)
 - The Clearing Account collected \$260 for the Gideons and paid out \$260.00. In addition, a plane ticket was purchased for Philip Sandi to fly to Texas for \$184.80 and will be reimbursed by the NALC.
 - Transferred \$288.94 from our Mission Fund to reimburse a check written from the General Fund to pay for a portion of a ramp for a member of River of Life Church.
 - When asked what was the Clearing Account, Lonnie explained that was created as a new line in the financial statement to show money that comes into the church and then is sent out again. She gave a recent examples of cash donations collected for the Gideons, which were counted and banked, and then a check was sent to them. The church does not keep any money from that offering.
 - The Mission Fund for the ramp was approved by Dave Jaessing as the fund had extra money. Dave and Pastor Paul felt we could contribute to a local community mission since we have more than sufficient funds in that account.
 - Lonnie also reported she has worked on updating the Memorial Fund and where or what the memorial money should be designated or restricted.

7. Board Reports:

- **Deacons** given by Mike. Present were Ric and Mike.
- There were 5 Sundays in October. The attendance for the 8:00 a.m. service had an average of 25.5 and the 10:00 a.m. service an average of 72 with a total average of 97 per Sunday. Mike reported that there are still 8 10 views on Facebook. Two names have been added for Deacons for the Ballot and will be sent to Jeanne.

- Will start locking the doors again 10 minutes after the 10 a.m. service begins with signs left at the doors.
- Planning for Congregational meeting on Sunday, Nov. 21 and potluck afterwards for about 50 people.
- <u>Elders</u> Given by Kent. Present were Kent, Jim, and Merlin.
 - Set the communion schedule for December will send to Jeanne.
 - O Looked at room that will be used for the Prayer Room. We decided to place a table in the room that will hold a Bible, cross, etc., and will either build or purchase a table. Also discussed purchasing partitions to add privacy to the room. Merlin will contact Ann Kidston to gather input from her on the room since it was her idea to utilize the area for prayer.
 - Elders will meet with Pastor Gruetter on Wednesday,
 November 18, to conduct his annual review.
 - Discussed open Elder positions and possible person(s) to fill the vacancies and forwarded them to Jeanne for the ballot.
- <u>Parish Education</u> Given by Megan. Present were Kati and Megan.
 - Gifts Kati will purchase: oranges, candy, activities for Christmas gifts given out Dec. 19
 - Advent calendars Megan will hand these out, but will check to see how many we have left from last year.
 - Christmas Program will be on December 19th, will ask Shawn Hendricks to do breakfast. We will have cookies and punch. Megan will purchase punch and ask Sue Dewire and Riki Timbrook about making cookies. She will also purchase ball caps for the kids in the program.
 - Early Communion Parker Stump, Rowen Saneholtz, and Braxton Henry will be participating. Megan will check with Merlin Wright about teaching the class in January and February.
 - Parish Ed is reaching out to youth who haven't come yet this year.

- He commented that passing the offering plates has improved offering amounts.
- President Nathan reminded to get new information for the voting ballots to the secretary as soon as possible.

13. New Business:

- President Nathan stated the House of Prayer wants to borrow our nativity scene for Old Tyme Holiday Gathering on Saturday, November 20. Motion to approve House of Prayer to borrow our nativity figures on November 20 made by Dale and seconded by Kent. Motion approved.
- Discussion was made about a security system and the trustees will continue to look into this.
- More discussion about keeping the baby Jesus safe in the Nativity scene, but nothing was decided.
- President Nathan stated Joy Gruetter gave him some information about purchasing One License to cover copyright permission on our songs, hymns, and other music. Pastor related that we have a CCLI license for our Praise and Worship service at 8 a.m. that covers those songs we sing, but says Joy thinks we need one for 10 a.m. service which will allow for streaming, especially for choir anthems. Nathan will look into what we need and the cost of what applies to our church.
- Pastor requested vacation from December 27 January 2.

ST. JOHN'S LUTHERAN CHURCH CONGREGATIONAL MEETING Sunday, November 21, 2021

President Nathan Thompson called the meeting to order at 11:08 a.m. following the worship service in the church sanctuary. He spoke a thank you for all the people who are a part of church, whether day to day, or Wednesdays and any other time to make sure this church is successful in Montpelier.

Pastor Paul Gruetter opened with prayer.

Copies of the 2022 proposed church budget, and voting ballots were passed out to the congregation. President Nathan stated that several names have been added since the previous proposed ballots were mailed.

Motion to approve the voting ballots made by Shawn Hendricks and seconded by Ryan Burt. Motion passed by voice vote.

Motion to approve to forgo reading of the November 22, 2020 meeting minutes made by Mary Wright and second by Bill Hill. Motion passed by voice vote.

President Nathan said thanks to all who have served as Council Board members this past year. A special thank you for those who have served and those who are leaving this year. He related that we have some areas to fill and asked for any nominations from the floor to fill the open positions on Church Council for 2022. One is Vice president, an Elder, and a Trustee. Nathan Baker volunteered to be a Trustee. President Nathan asked if anyone would like to serve, please contact Jim Engels, Pastor Paul, or Secretary, Jeanne Willson. Motion to approve the 2022 Slate of Officers made by Dale Gearhart and seconded by Shawn Hendricks.

President Nathan highlighted few changes in the 2022 church budget. One change is on the Other Benevolence line item is added back in this year. An example would be if something comes up in the year such as, someone asking us for a donation during the year that we would want to fund. Since the NALC Convocation is now a two-year event, it has been taken off this year, but will be added in next year. For salaries, Intern's salary is listed as a line item, even though a generous donation has been given to fund this, it still needs to be listed. Pastor Paul is available for Medicare so that lessened the burden on the church and shows a change in his insurance. The treasurer's position is changed with Valerie Steinke doing the day – to – day expenses and Lonnie Gillen, helping as the Trustees felt it was a lot for one person to do. President Nathan talked about how the Trustees have put off some projects that need to be taken care of The carpet needs repair and the windows need in maintenance. repairing. Also, the west parking lot needs replaced, but will be done in 3 stages. When member Sally Taylor questioned how this will all be paid for, Lonnie Gillen explained the fund called Capital or Contingency fund that will be used for this. She has also contacted Memorial recipients to see if anything is not designated that could be used. Motion to approve the 2022 Budget made by Jim Engels and seconded by Dale Gearhart. President Nathan asked the congregational members to mark Yes or No on the Budget on the Voting Ballot. He also reminded members to mark an X for the Slate of Officers

President Nathan asked Pastor Paul to explain about ratifying the NALC Amendments. Pastor Paul explained when the NALC was

founded, they didn't know what to call the districts. We now use the words Mission Districts and Mission Regions, but these names were not actually in the NALC Constitution so will need to be ratified to be used. Motion to ratify NALC Constitutional Amendment 11 made by Shawn Hendricks and seconded by David Jaessing. President Nathan asked the congregational members to mark Yes or No on the Ratification of Constitutional Amendment 11 Voting Ballot and the Deacons will collect them.

While the Ballots were being counted, President Nathan explained about the Building Fund money has now been put into 2 different CD savings accounts to get more interest. Also, Dale Gearhart, Trustee, wanted everyone to understand that how our offerings have been affected by the economy and he appreciates the fact the church employees didn't mind that their salaries were frozen.

President Nathan spoke of his appreciation in everyone's help with the Congregational Meeting and everyone on council. He encouraged someone to be a volunteer to be Vice president next year and invited everyone to go downstairs and enjoy the potluck.

Motion to adjourn the Congregational Meeting made by Mary Wright and seconded by Kent Hutchison. Motion passed by a voice vote.

Everyone stood and said the Lord's Prayer together.

NOTE: After the meeting was adjourned, the results of the 2022 Budget Voting Ballot passed 44 Yes to 1 No. The results of ratifying the NALC Amendments passed 45 yes and 0 No.
