

From the Pastor's Desk

"Five Questions that Might Change your Life"

The Apostle Paul had not yet visited the church in Rome, but he was concerned about the growing schism that existed there. All Jews had been expelled from Rome by Emperor Claudius around AD41 leaving only Gentiles Christians to build the church. Around AD53, Jews were allowed to return only to discover that Roman Christians were not very welcoming to them. This created a tension that Paul addresses in his letter to the Romans.

Within this letter Paul asks five questions which might easily fill his readers with a sense of hopelessness, although these are being asked by God to His church in order to give real hope. These questions are put forth as arguments so that we can overcome doubt and fear, and experience peace and comfort in a world turned upside down and inside out.

- 1. If God is for us, who can be against us? (Romans 8:31)
- 2. If God did not spare his own Son but gave him up for us all how will not also, along with him, graciously give us all things? (Romans 8:32)
- 3. Who will bring any charge against those whom God has chosen? (Romans 8:31)
- 4. Who is he that condemns? (Romans 8:34)
- 5. Who shall separate us from the love of Christ? (Romans 8:35)

All five questions demand negative answers. **No one** can be against us to undermine God's purposes to do good to us and not harm. Who can be against us? Throughout eternity God is for us at all times and in all situations causing all things to work together for our good. Our greatest good is not our health, wealth, or success, but our life in Christ.

Next, let's follow Paul's logic. His argument is from the greater to the lesser. If God did not spare His own Son but delivered Him up to suffer damnation on the cross for our sin, then God will most

certainly freely give us everything we need for life in the here and now.

Who can bring a charge against us in God's courtroom and make it stick? Our conscience accuses us and we feel the guilt and shame of our sins. Satan is ever active to rub our noses in our sins and accuse us before God. But it is God who justifies. He has acquitted and pardoned us of all our crimes against heaven through Christ's obedience.

<u>No one</u> can bring any charge against us because we are righteous in Christ. Before the Law we are all worthy of condemnation for our sins. But because Christ died – more than that, who was raised to life – he is now at the right hand of God interceding for us. The One, who has the moral and legal right to punish us, is the One who now defends us before God. Death has lost its sting and God's judgement has lost its terror for there is <u>no condemnation</u> to those who belong to Jesus. Absolutely <u>no one</u> can condemn us.

Finally, <u>no one</u> can separate us from the love of God that is in Christ Jesus. While it is true we may experience trouble or hardship or persecution or famine or nakedness or danger or violence - nothing can ever separate us from the love of Christ. "Neither death nor life, neither angels nor demons, neither the present nor the future, nor any powers, neither height nor depth, not anything else in all creation will be able to separate us from the love of God that is in Christ Jesus our Lord" (Romans 8:38-39).

All five questions now demand a positive answer. In Christ, God is for us. In Christ, God graciously gives us every thing we need. In Christ, we now stand righteous before God's law. In Christ, our condemnation has been swallowed up. In Christ, God's love is invincible. In Christ, we have peace and comfort as we face the reality of death.

- 1. <u>Meeting Called to Order:</u> Vice President Ryan Burt called the meeting to order at 11:49 a.m.
- 2. <u>Approve the Agenda:</u> Pastor Marc questioned the use of the wording under New Business: "New Verbiage for resolution for St. John's constitution" and stated it should be "New Verbiage for the NALC Constitution and ratification of the amendments" to be discussed and voted on at the congregational meeting. - 11. <u>Half-Time Prayer:</u> Given by Pastor Marc.


12. Old Business:
