#### **INSIDE THE PUB**

WHEN DRINKING OR DINNING INSIDE THE PUB IT WILL BE TABLE SERVICE ONLY. WE UNDERSTAND THAT THERE MAY BE OTHER CUSTOMERS THAT ARE YOUR FRIENDS BUT, WE ASK YOU TO STAY AT YOUR TABLE WITH YOUR OWN PARTY. THERE WILL BE CLEAR SIGNS ON HOW YOUR PARTY CAN ENSURE YOUR EXPERIENCE IS SAFE AND ENJOYABLE. PLEASE REFRAIN FROM MOVING ANY FURNITURE.



#### FACE MASKS

WHEN ENTERING THE PUB, USING THE FACILITIES AND EXITING THE PUB FACE MASKS MUST BE WORN. FACE MASKS CAN ONLY BE REMOVED WHEN SEATED AT YOUR TABLE.



#### **TRACK & TRACE**

TO COMPLY WITH GOVERNMENT GUIDELINES YOU WILL BE REQUIRED TO LEAVE AT LEAST 1 PERSONS DETAILS PER PARTY. WE WILL FOLLOW ALL GDPR REGULATIONS AND HOLD ONTO YOUR INFORMATION FOR 28 DAYS. THERE IS ALSO AN OPTION TO CHECK IN VIA THE NHS COVID-19 APP.
