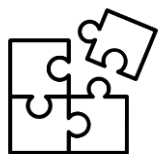

### **Masterclass 101 - Introduction to Regulatory Affairs**

## **2. FULL MEDICINE EVALUATION SHORT COURSE**

Ideal for:

Learners who wish to add further skill or refresh their medicine screening, reporting & evaluating skills as regulators. This short course can also benefit those aspiring to enter the regulator SAHPRA or fast track their understanding of a new role.

### **Masterclass 201 – Introduction to Medicine Evaluations**

Duration: approximately 2 hours +

Location: online

Additional Features: Homework, Assessment, Additional Guidance Resources, Certificate

Once a medicine dossier is compiled and submitted, it then needs to be evaluated. The regulatory authority has various departments which handle these evaluations. Understand the overall procedures and timelines for generic applications. Lets look at SAHPRA, its mandate and activities in light of this.

### **Masterclass 202 – Submission Screening**

Duration: approximately 2 hours +

When dossiers arrive after a submission, they are screened for correctness and completeness. Learn the process followed by SAHPRA and understand what to look out for during technical screening. Queries are sent to applicants when findings and shortcomings emerge. These can be sent merged with other queries or on their own. Learn what query examples are and use templates to write them. Learn to use the submission trackers available online in a timely manner as strict timeframes and rounds for each type are implemented.

### **Masterclass 205 – Evaluation Outcomes**

To obtain and maintain SAHPRA compliance towards complementary medicines, one needs to know how to correctly classify them (herbal supplements or discipline specific), and what the registration requirements are (PI/PIL, 3D list, desktop application form etc). learn all of the latest requirements while doing a practical example of your own in your homework.

### **Masterclass 108 - Medical Devices: Licensing + Startup**

## 9. MENTORME PROFESSIONAL DEVELOPMENT PROGRAM

Our mentor me program which started in 2020, has been assisting young inexperienced pharmacists (mentees) with insight, practical learning and personal development tools through our volunteers who are more experienced and sector specific experienced mentor pharmacists. We use a pairing system to match mentees to mentors. The program is 6 months long and can be renewed.

## 10. CALENDAR (RECORDED & LIVE SCHEDULE) & PRICING

Recorded courses are available monthly. Learners need to register or enrol the month before or earlier to reserve their space for the 1<sup>st</sup> of the month they wish to begin. Live courses are only available according to the calendar below. Learners are required to book at least 2 weeks in advance to reserve their limited spaces.

## 11. CONCLUDING REMARKS



We trust, you have found our Pharmers Academy brochure insightful.

Upon completion of any of our courses, all learners will receive certificates. With the full courses, they will also automatically receive a summary of outcome in a recommendation letter. Referral letters or referee requests will be reviewed on a case by case basis.

**Accreditation status:** we have submitted a full application for providing a short course with SAPC and it is under processing.

### Enrolment Durations

Learners have a lifelong enrolment number to be used with any returning applications.

Recorded masterclasses are taken at your own time and convenience, therefore completion is also dependent on your own pace.
