I understand it is my responsibility to give this 30 days notice and I am responsible for tuition up to and including this time period.

**Tuition:** I understand that tuition is based on a 10 month Session billing. *I agree to pay monthly tuition by the first day of each month*. I understand that Easley Gymnastics preferred payment is Automatic Bank Draft and that if I choose this option, I will receive a \$5 per month discount. ALL late payments will incur a \$10 fee per month, if payment is not received by the 1st of each month. I understand my child will not be able to participate in class until tuition has been paid. We do not mail tuition reminders. There are no refunds or credits issued for missed practices.

**Make-up Classes:** I understand my child may make up a missed class during another class time and that I must preregister for this class, in classes with available space.

**Returned Checks:** There will be a \$30 fee for all returned checks or a credit/debit card chargeback.
