If children are present, they should be supervised to ensure they do not play with the HTS. (Clause 7.12)


If the Supply cord is damaged, it must be replaced by the manufacture, its service agent, or similarly qualified person in order to avoid hazard.







2. REPEAT STEP ONE WITH OPPOSITE ARM.

Operating Instructions

- 1. Remove position pin and rotate mouth of barrel upwards.
- 2. Fill material housing with product.
- 3. Replace safety lid and position pin.
- 4. Plug in machine.
- 5. On timer, while in standby mode, press **SET** and "**O**" will be shown on the display.
- 6. Modify the time interval with the up and down buttons.
- 7. Press "SET" to enter time and start run cycle.
- 8. Remove Safety lid and position pin.
- 9. Dump product in desired container.
- 10. Repeat.

-Use only plastic cleaner on safety lid.


-Clean material housing with alcohol, wipe down and do not saturate bearing or the inside of the barrel.


Maintenance Sheet
