



North Atlantic Fastpitch Waiver & Release

Reading and Accepting these Terms Conditions (collectively called "Terms") are required before gaining the right to use our site.

Access to the North Atlantic Fastpitch site is strictly prohibited without your acknowledgment and acceptance of such Terms.

These Terms may change from time to time. As a visitor or client, you are encouraged to review this section periodically.
