Details:

- **There is a \$100.00 fee to be at the festival.**

- Be there at 10am for Set Up on May 30, 2026
  - Trucks and Food Booths will be set up in the West Parking lot and visible from James
  - You must be self-powered
  - You must have your own food permits
  - **You must complete and submit the Public Health Dept Documents that we will provide to you.**
  - You must have your own liability insurance
  - You are responsible for providing utensils, napkins, plates, etc.
- **Food truck or Food Booth serving hours 11am - 4pm**
  - We ask that you do not close before 4:00 pm
- **You get to keep all profits!**
- KIF requests you have at least one/two moderately priced (\$6 - 8) plates
  - Can be a KIF special
  - Can be a smaller "sample" plate
- Please have beverages available for sale
  - **Absolutely NO alcohol sales allowed**
- We ask that you publicly and actively promote your upcoming participation at KIF
  - In return, we will advertise your involvement with the festival via our social media platforms, print material, etc.
  - Please provide a high-resolution version of your logo and website links for our promotional purposes

*Please display or have available ingredient listings that show any common food allergens (wheat, nuts, dairy, etc.) and if dishes are vegetarian, vegan, hallah, etc.*
