

# The Property




- 1. Move projects under consideration.
- 2. Property transfers.
- 3. Complete Site Master Plan
- 4. Plan for Infrastructure Financing

### Cambridge Shipyard Facility

- 5.5 acres/Port Property
- 820 ton travel lift
- 3 large maintenance buildings + office building
- Has invested in engineering and permit applications.

### RAR

- 2 acres +-/Port Property
- 2 brewery and taproom
- At the promenade with open area for entertainment



## Port Property

- 12 acres including promenade
- City owns but State has authority to approve sales with approved development plan
- Intention since formation of CWDI has been to transfer the property to CWDI to manage development. (LOI in Nov. 2019)

## Port Property

- Once City gives approval to property transfer, the request will go to State for approval.
- Timing has become a critical issue for Cambridge Shipping Facility re willingness to proceed with additional engineering costs, financing of project, and construction window.
- Sale proceeds are needed for infrastructure financing (Phase 1).

# Hospital Property (Shore Health)

- 19 acres includes 3 buildings (hospital, nurses quarters/offices, medical offices)
- Shore Health has completed a hospital decommissioning report but needs additional information.
- Negotiations for purchase of property to begin Mid March.
- Buildings to be vacated in Sept/October and available to CWDI about the first of the 2022.

# **County Property**

- Up to 2.7 acres playground, parking and portion of amphitheater site
- CWDI contemplates moving outdoor performance venue closer to entertainment/commercial area
- Would add land area for open space and recreation development.
- May require DNR review.

- CWDI has done conceptual site plans, primarily for Port Property.
- BCT Design Group has just submitted final report on citizen survey to CWDI for review.
- Next steps:
  - virtual presentation to stakeholders
  - > 2 Follow up meetings to share Master Plan concepts

- ◆ BCT/MRA to do preliminary engineering:
- ◆ Roadways, sidewalks, underground utilities, lighting, walkways and bikeways, fiber optic broadband.
- ◆ Est. \$8 million
- ◆ Maybe able to access federal \$ but will have to be matched 20% to 50% and produce jobs.
- ♦ Without grants, local financing will be required.
