## Vendor Rules & Information

1. Vendors must be completely set up by 9:45am on the date of the event. Gates open at 8:00am for all vendors. Vendors agree to maintain normal operations until 3:00pm and must be completely cleaned up and ready to leave no later than 4:00pm. AREA PROVIDED MUST BE LEFT IN SAME CONDITION AS WHEN ENTERING THE EVENT. Trash / recycling removal in designated areas only.
2. A Connecticut Food License/Permit will be required by the State.
3. Connecticut/Stamford Health Inspector may choose to inspect vendor's tent/trailer. A valid Health Department Permit and adequate insurance are required.
4. Vendor willingly and knowingly releases JM Wright Tech PFO from all liability associated with Vendor's participation in the event; and waives any claims and or causes of action against JM Wright Tech PFO associated directly or indirectly with Vendor's participation in the event.
5. It is the sole responsibility of the Vendor to have all proper permits and licensing in place. Vendor hereby releases JM Wright Tech PFO from all liability resulting in levied fines, penalties or other claims associated with Vendor's failure to secure and maintain proper permits and licenses.
6. All cooking, heating, cooling equipment must meet the State of CT /Stamford Fire Department standards. Vendor shall maintain standard safety procedures/policies at all times. JM Wright Tech PFO is not responsible for ensuring Vendor adheres to these procedures/policies, and Vendor hereby releases JM Wright Tech PFO from all liability for claims or other causes of action resulting from Vendor's failure to comply with this paragraph.
7. Vendor's vehicles may be driven and parked in designated areas only. Vehicles are not permitted to stay with vendor location unless it is a food truck.
8. Vendors must supply their own tables, tents and chairs. No electricity is available. Vendors may supply their own power, must be noted at time of application.
9. Vendors must remain at their booth/truck at all times.
10. Vendors must be adequately insured. Vendor Liability Waiver must be signed and submitted along with Proof of Insurance to show organizers with initial application.
11. The show organizers, including but not limited to JM Wright Tech PFO, will not be responsible or liable for any loss, damage or harm to Vendor's property or person. The event organizers, including but not limited to JM Wright Tech PFO, are not responsible for lost or stolen articles.
12. There is a rain date for the show, one- two weeks after the original date.
13. The JM Wright Tech PFO reserves the right to deny admission to a Vendor for any reason.
14. Payment MUST be received by JM Wright Tech PFO no later than date listed on page 1.
15. Goody bag advertising submissions need to be received by date listed on page 1.
