Health Guarantee:

- The BUYER is recommended to have the puppy examined by their veterinarian as soon as possible, though it's not mandatory and does not affect the health guarantee. Any health issues should be reported to Ponderay Pomsky promptly.
- The puppy comes with a 1-Year Health Guarantee covering hereditary, genetic, and fatal health issues. If determined to be suffering from any fatal hereditary defect, Ponderay Pomsky will fully refund the dog, including the \$250 deposit. For non-fatal hereditary defects, medical costs for treatment up to the purchase price will be reimbursed with proper veterinary proof.

Genetic Testing:

Parents of the puppy have been genetically tested and cleared of breed-relevant diseases. Embark genetic panel results are available online.

Non-Guarantees:

Breeder does NOT GUARANTEE against Coccidia or Giardia, final adult weight, coat color/ pattern, eye colors, cryptorchidism (refunded if breeding rights purchased), or conditions caused by environment or diet.

Buyer Acknowledgment:

The Buyer acknowledges reading and understanding the guarantees and non-guarantees. The importance of completing puppy vaccination rounds is emphasized.

Spaying/Neutering:

The Buyer is recommended to avoid premature spaying/neutering, and the Breeder will honor the Buyer's choice. The buyer is required to provide proof to the seller that spray/neuter has been performed.

Vaccinations and Deworming:

The Breeder states that the puppy has received vaccine at 6 weeks old and has been dewormed. Deworming schedule and details are provided in the puppy's health record.

Buyer Responsibilities:

The Buyer agrees to provide adequate shelter, veterinary care, nutrition, training, and proper treatment for the dog. Re-homing must be discussed with the Breeder, and abuse is not tolerated.

Refunds and Breeder Rights:

- Return Puppy Refunds: Up to a 50% refund, depending on the length of the puppy's stay, will be issued AFTER the puppy is safely replaced into another home.
- Breeder retains all rights to the puppy and can void the contract if there are doubts about the puppy's well-being.
- The Buyer agrees to prevent accidental or purposeful breeding without breeding rights and to contact the Breeder in case of accidental breeding.

Lifetime Breeder Support:

The Buyer is entitled to LIFETIME Breeder support. Updates and contact with the Breeder are encouraged.
