



# Sandbox Bouvier Puppies

## Health Guarantee

You, the Buyer, have been provided with a complete vaccination and worming record for your puppy. Please take the puppy, along with these health records to your vet within 72 business hours of receipt of puppy for a health check (we understand due to Covid that this time frame may not be possible, please let us know if you are not able to make the 72 business hour deadline and we will give you an extension, we know times are different). You are required to return a signed and dated copy of this Health Guarantee, along with a copy of the vet's health check receipt within 7 days of receipt of your puppy. This can be mailed or scanned and emailed back to us. Failure to do so renders this Health Guarantee null and void. Please check the shot and worming record and have the booster shots and wormings given at the proper times. Failure to do so will render this Health Guarantee null and void. Your puppy is guaranteed for 7 days from the date of receipt from all diseases for which it has been vaccinated against, excluding worms, coccidia and giardia which are common in puppies, there is no vaccination for coccidia or giardia. Your puppy will have preventative treatments for coccidia and giardia, but there is no guarantee that your puppy may not have coccidia or giardia upon arrival since it can be easily gotten from a puddle in the yard or picking up sticks to play with. Color is not guaranteed, the Bouvier breed is known to get darker and lighter as the puppy/dog ages (it is part of the beauty of the breed). Breeder is not responsible for refunds for treatment of coccidia or giardia because it is known to be a common issue with puppies of any breed. Your puppy is also guaranteed against both fatal genetic and fatal congenital defects for one year from the date of birth. In the event that your vet finds a fatal defect at your puppy's first check up, or anytime within its first year of life, you, the Buyer, must notify the Seller within 24 hours. Seller requires a veterinarian's letter from a brick and mortar office and date of diagnosis concerning the fatal condition, and reserves the right to request a second opinion at Buyer's expense. No cash refunds only a replacement puppy will be offered (same value excluding ear cropping if ears were cropped), original puppy must be returned to Seller for a replacement if under 6 months of age. Buyer must pick the replacement puppy within 12 months, otherwise there will be no replacement of puppy. ANY puppy replacement will be done at Seller's discretion only. Return shipment of the puppy will be made at Buyer's expense. If a fatal congenital defect is discovered, and Buyer chooses to keep the dog with the defect, Buyer releases

Seller from any and all responsibility of incurred vet and other expenses of said dog. If the condition is fatal, an autopsy is required to determine cause of death, which is the sole responsibility of Buyer. Should Buyer decide to euthanize the dog without Sellers permission, this Guarantee is null and void and Seller has no financial responsibility to Buyer. Further, if buyer has purchased puppy with a Limited AKC Registration as a pet/companion. Breeding without permission of Seller is absolutely prohibited and will cause Buyer to be open to every legal remedy available to Seller. **Spaying and neutering is required by 12 months of age, if that is NOT done the health guarantee is null and void, UNLESS you purchased full AKC.** All vet expenses are the sole responsibility of Buyer as soon as the puppy is purchased and in Buyer's possession. In the event Buyer cannot keep the puppy anymore, for whatever reason, Seller must be notified as soon as possible. You, the Buyer, hereby agree that Seller will have first right of refusal of the puppy/dog. **Buyer further agrees puppy/dog is never to be given to an animal shelter or rescue society.** Traveling/shipping costs are the responsibility of the Buyer. If buyer cannot keep your healthy puppy there will be no refunds/exchanges. Puppy will be returned at the buyers expense. This guarantee is a non-transferable contract between original Seller and Buyer. Any transfer of this animal by the original Buyer will void the Health Guarantee. You are advised to make a copy of this Health Guarantee for your records. Your signature represents your agreement with the terms stated herein.

Both parties (and agents) agree to a full and absolute nondisclosure of any part of this transaction and return and agree to liquidated damages equal to the initial payment price of puppy if found to violate this clause. Sandbox puppies respects the privacy of their buyers and will never sell, share, transfer ANY names, addresses, numbers to any marketing firms or any other persons/agents. Information will always be kept private.
