PARK RULES & INFORMATION

AIR CONDITIONERS & HEATERS - Please turn off air conditioners and heaters when not in dwelling.

AMENITIES - Please leave all amenities the way you would like to find them. Children are not to play in or around the amenities blocks or Camp Kitchen. Children under 10 must be accompanied by an adult to the bathrooms.

BEHAVIOUR - All site occupiers have the right to the peaceful and quiet enjoyment of their site. Excessive noise, violence, unruly behaviour or bad language WILL NOT be tolerated at any time. - Management reserve the right to evict anyone for bad behaviour.

BIKES - Helmets are to be worn at all times. No bike riding after dark.

BOATS - Boats are not to be moored at the beach area. Cleaning of boats on site is prohibited.

CAMPFIRES - Campfires are only permitted in approved drums and in line with CFA regulations. Strictly NO ground fires. Fires are never to be left unattended. Ensure that coals are extinguished and disposed of in trailer located near skip bins before departure.

CHECK IN / CHECK OUT - Check in is from 2pm. Check out is before 10am.

GENERATORS - Generators are strictly prohibited.

NOISE - All noise must cease by 11pm. Quiet time is 11pm to 8am.

PETS - Pets must be kept on a lead at all times. It is the responsibility of the owner to control and clean up after your pet. Pets are strictly prohibited in the amenities blocks and cabins. Under no circumstances are pets to be left unattended.

PLAYGROUND - Playground is to be used in daylight hours only. Use of playgrounds is at users own risk.

REFUNDS - Refunds will not be given for early departures..

RUBBISH - Rubbish is to be bagged and placed in the skip bins, see map for location. General rubbish only. Recycle bags are only for cans and bottles with the 10c return symbol. These recycle bags are picked up for charity. Please DO NOT place general rubbish in them.

SMOKING - Smoking is prohibited inside any enclosed buildings within the park. This includes, but is not limited to cabins, amenity blocks, camp kitchens, reception buildings. Within 4 metres of the entrance and/or exit of the reception building. Within 10 metres of a children's playground or any other recreational facilities. Please note: Failure to comply with our smoking policy will result in a \$250 fee being charged.

SPEED LIMIT - In the interest of safety the speed limit is walking pace only. Speeding in the park WILL NOT be tolerated.

TREES - Trees around the park are inspected regularly, however trees and branches may still fall. All guests enter the park at their own risk. No responsibility will be accepted for personal or property damage caused by falling trees or branches.

VEHICLES - Only one car per site. If you have a 2nd vehicle you may be required to park it in the car park area. Vehicles are not to be driven over or parked on vacant sites.

VISITORS - All visitors must report to office upon arrival. Visitors cars must be left in the car park. Day visitors must depart by 11pm, or pay overnight guest fees.
