I, the undersigned, have enrolled my dog(s), as described above, in pet lodging services (the "Pet Lodging") offered by Working Paws Training Inc.

By signing hereunder, I certify that I have been informed and understand that there is always some unavoidable risk of injury involved when working with and lodging animals, especially animals with behavioral issues such as dogs. I acknowledge that dogs can be inherently difficult to control and that not all dogs will be under control at all times, even in the absence of negligence, resulting in the possibility of injury to myself, my dog, my family members, third parties, and /or my possessions including, but not limited to, my home and home furnishings. Additionally, I have had full opportunity to discuss all concerns I have about the foregoing risks with Working Paws Training, Inc. and its authorized representative. I have also made all inquires and investigations to my satisfaction related to such risks including, but not limited to, an examination of the lodging and/or training area (if applicable).

I hereby accept and assume, without reservation, all risks associated with my participation in the Pet Lodging, including, but not limited to: the risks of any and all injuries to myself, my dog and any of my family members or third parties who may be present; the risks that my dog may cause injury to other persons and/or dogs involved in the Pet Lodging; the risks that my dog may damage or destroy certain personal property while in Pet Lodging; and the risks that saliva, water, food, snow, and/or other debris may be present in the training and lodging area. I have read and understand Working Paws Training, Inc.'s Operating Policies, and agree to abide by them to the extent applicable.

As lawful consideration for participating in the pet lodging, I, for myself, my heirs, executors, administrators, legal representatives, successors, and assign (the "Releasing Party"), hereby waive, release, discharge and agree not to sue and to indemnify, defend and hold harmless Working Paws Training, Inc., and their members, managers, agents of any nature whatsoever, including claims arising from the Release Party's own negligence, and all costs associated therewith, including attorney's fees, court cost and consultant fees, arising from my participation in the Pet Lodging.

This Waiver of Liability & Informed Consent Release shall be legally binding on the Releasing Party. Should the Releasing Party assert a claim to the contrary to what I have agreed to in this Waiver of Liability and Informed Consent Release, the claiming party shall be liable for all expenses (including attorneys' fee, court costs and consultant fees) incurred by both the Releasing Party and the Released Party. No waiver or modification of any provision herein shall be valid unless expressly agreed to in writing by both the Released Party and the Releasing Party.

Every provision herein is intended to be severable. If anyone or more of the provisions herein is found to be unenforceable or invalid, that shall not affect the other terms and provisions hereof, which shall remain binding and enforceable. I represent that I am at least 18 years of age and have the capacity to enter into this agreement.
