### Ann distributed SECA Treasurer's Report

- Dock Account Balance = \$16,148.05 (as of 3/15)
- General Account Balance = \$13,723.77 (as of 3/15)
- Dock Slip balance for lottery winners was due March 1 but several folks are delinquent; Bill will follow-up w/ those who have not yet paid
- Annual Budget Bylaws state we need to discuss budget yearly

- 2017 Budget Considerations
  - Need to replenish sand at Anchorage Beach; Mega-Materials delivered dump truck load of sand 2 years ago for about \$300; Jason will get pricing and available delivery dates
  - Need to replace some planks at boat dock
  - Need to assess canoe/kayak racks for repairs

### Spring Clean-Up:

- Boat Dock Some planks need replacing; Piling cap paint from Fall Work Party still looks good
- Canoe/Kayak Racks at Anchorage Beach and Boat Dock
  - Need to assess general condition of racks, and repair as necessary
  - Trim foliage from around racks for better access
  - Racks are full of canoes/kayaks some of which are not used determine whether additional racks are needed, and whether any boats are abandoned
  - Many boats are padlocked to rack need to know who owns boats in case something happens so we can contact owners
  - Consider numbering 'spaces' on racks to help identify boats and owners

- Consider complimentary boat storage on racks for SECA Members, and charge nominal fee (perhaps \$25/year?) for non-members
- Linda and Kim will draft an e-mail notice to community (prior to the Spring Cleanup notice) to ask folks to identify/claim their boats and remove them before Spring Clean-Up until racks can be assessed and repaired
- If boats are not identified and claimed before Community Picnic in September, consider auctioning those boats at the Picnic
- Spring Clean-Up date Saturday May 6 at 9AM (rain date May 13) Linda and Kim will draft a notice for SECA members
- Jason will schedule sand delivery for Beach after Clean-Up and before Memorial Day

## Insurance Policy:

- State Farm is insurer and Hank Starkey is our agent Needs (D&O) Directors and Officers contact information
- Tidal wave and ice/freezing are not covered losses (it's \$2500 to cover those items); Otherwise
  policy and deductibles are inline w/ what is expected; Docks are also not covered (typical of
  policies for similar situations)
- Jason recommends to keep policy as is even if land transfer occurs
- Coverage description needs to be more accurately defined and in writing; Needs to use 'dock' in description. Jason will get the policy updated to reflect this
- Jason will distribute a copy of policy to Board Members in case Hank needs to contact someone
- D&O = \$1M (Standard); Liability = \$1M (Injury covered under general liability)
- If SECA owns common areas, is a different policy needed? No

## Land Transfer:

- Board Members continue to research and gather information/recommendations regarding common areas and right of ways in our community based on the conversation Jeff Russell had w/ Bob Hodges that he shared at the Annual Meeting
- Ultimately we want to protect Shorewood Estates property owners and Civic Association along w/ access to common areas and right of ways
- Any activity or decisions will be in consult w/ an attorney and all Shorewood landowners

### **Bylaws:**

- Kim will send Bylaws to Board Members to review (discussion tabled until next meeting)
- Previous concern w/ accuracy of financial accounts that led to 2 signatures for every check from SECA; Former past-presidents Dan Buyse and Bill Berghaus are currently providing 2<sup>nd</sup> signatures but are no longer Board Members
- Second signature should consist of then current Board Officers (President, Vice President, Secretary, Past-President)
- Kim and Ann will follow up with People's bank to get current officers as signers on account.

### Sign:

 Need property owner's (Bob Hodge) permission to erect a permanent 'Shorewood Estates' sign on Shorewood Rd; Jeff will talk to Bob and will provide specifics about intended sign. Sueann will provide details about a permanent sign design Sueann & Brian will post community events signs and will continue using the current sandwich board' style sign for now.

### Mailboxes:

 Follow-up from Annual Meeting – Linda sent e-mails to property owners on private roads (Duck Hollow and Sassafras Rd); All owners from Sassafras Rd responded and agreed to grouped mailboxes on a common rail system similar to those on other private roads (Swantown Creek Rd, Pineywood Rd, and Anchorage Lane); Still waiting for responses from all owners on Duck Hollow
