# Land Transfer – Attorney Memo and Recommendations

- SECA is not considered a Homeowners Association (HOA); It is considered a Civic Association, therefore the Board and its members can make decisions under the rules and guidelines of our current Bylaws; If SECA was a Homeowners Association any and all decisions involving the homeowners would need a 100% participation
- Changing SECA into an HOA would require 100% unanimous vote of all landowners
- SECA as a Civic Association can acquire property
- Any common property acquired and owned by SECA would still need to allow all homeowners access to common property
- Land that currently houses the airstrip can be sub-divided; What is not clear (and would need further review) is whether that land, if developed, would become part of Shorewood Estates and would have access to common areas
- Last ruling in 1991 judgement stated that the current plat is the 'Final Subdivision' and it shows the airstrip property only as 'Future Development'; This would need further investigation, but by all accounts at this time, Shorewood Estates is complete; A title abstract would allow us to determine if this land was even considered part of Shorewood Estates
- Finally, the attorney suggested we obtain further information about ownership of waterfront property and liability; Currently, SECA has a liability policy in place nothing would need to change for insurance purposes
- Jeff Russell will talk w/ Bob and Elizabeth Hodge to ask about their intentions of transferring the common areas to SECA

### Anchorage Lane Common Area Encroachment

- Jack Kennedy built a fence and gate on property adjacent to his that encroaches on the Anchorage Lane common area owned by Bob Hodge; Jack sent a letter to Bob Hodge and SECA stating the reason for the gate/fence was to stop further parking and trespassing on his land; He proposed an agreement to Bob for a renewable ten-year lease paying \$5K to SECA for each 10 year lease period plus his continued maintenance of the Anchorage Lane shrubbery (of which he has maintained without cost to SECA for many years)
- Board Members reviewed Jack's letter and fence/gate position, and voted to recommend that the Hodge family consider Jack's lease proposal
- Motion by Jeff to recommend Kennedy lease proposal; Bill 2<sup>nd</sup> motion; All present agreed w/ 'aye'

### SECA Treasurer Vacancy

- Linda, Kim, and Sueann will tag team Treasurer responsibilities for remainder of this year unless someone volunteers to join the Board as Treasurer
- Need to inform Community that Ann resigned; Based on Bylaws, ask if any SECA Member is interested in being appointed to fulfill Treasurer position for remainder of this year

### Shorewood Estates Civic Association (SECA) Board of Directors Meeting June 26, 2017 at the Righi's Home

- Ask People's Bank to reconcile accounts and set-up electronic banking; Merge General and Dock checking accounts then convert one into an interest-bearing savings account; It was noted that the accounts had been used interchangeably over past several years
- Motion by Sueann to combine Dock and General Accounts and open interest-bearing account; Jeff 2<sup>nd</sup> motion; All present agreed w/ 'aye'
- We will send Ann a thank you card from Board Members w/ VISA Gift Card each Board Member agreed to contribute cash personally so no SECA money is used

# Anchorage Beach Sand and General Maintenance

- Update need another truckload of sand as 1<sup>st</sup> one was not enough; Sand is flushing out between 'cement blocks'
- Suggestions were to build-up blocks w/ fabric to help sand from flushing out, and build rip-rap w/ rock
- Obtain 2<sup>nd</sup> truckload of sand and determine what to do next Spring; Kim will check with county to make sure putting sand at beach is permissible
- Large branch fell at Anchorage Beach near picnic tables and a large section is still partially hanging; Concern w/ upcoming Holiday and folks using Beach; Brian offered to check tree branch, and cut up/remove for firewood
- Kim confirmed with Travis that we want him to maintain Beach Hill
- Kayak/canoe rack storage at Anchorage Beach is full; Boat dock storage racks are not full; Rack space at Anchorage can move a rack from Dock to Beach if needed or build another rack; No one in the Community has asked for additional space; Tabled until a need for a new rack is identified

# Common Rail Mailboxes

- Friedrich is ready to make new common rail system for mailboxes at Sassafras Rd and Duck Hollow Dr
- Will return old mailboxes to owners when new systems are built
