Treasurer Report (RoseMarie)

- Review current balances (as of 06/01/2020)
 - Checking = \$219.81
 - Savings = \$25,413.41
 - Total = \$25,633.22
- Highlights = Dues collected from 56 of 80 properties; All 9 Boat Slips awarded in Lottery (\$5850); Dock Fund donations collected = \$1200; Bob Hodge donated \$2500 for SECA Shed
- Rose will send detailed Q220 Financial Report to Board Members by July 15

Membership Report (Linda)

- Membership Dues at 56 of 80 properties = 70% (2019 Dues at 61 or 76.3%)
- Extended Dues payment date due to COVID-19; Linda sent reminder e-mail to long-standing Members in April 7 of 14 responded w/ Dues payment
- Shorewood Estates website fees are due by end of June (~\$175)
- Kim will send another Dues reminder; Linda will pay website fees

Spring Clean-Up (Kim)

- Postponed 'traditional' single day work-teams Spring Clean-Up due to COVID-19 stay-at-home directives and gathering restrictions
- New strategy -
 - Create list of typical tasks performed for annual common areas Clean-Up
 - Ask neighbors to volunteer for tasks as individuals, families, or groups (keeping CDC COVID Guidelines in mind)
 - Sign-up for task(s) and complete at leisure by Friday 6/26
 - Any outstanding or incomplete tasks will be completed on Saturday 6/27 or Sunday 6/28 depending on weather
- Linda will send e-mail to community by end of week

Finalize SECA Shed Purchase and Permitting/Installation (Kim)

• Confirmed and obtained very generous \$2500 donation for shed from Bob and Elizabeth Hodge

- Sheds researched for consideration include, 1) 10'x12' wooden vinyl-sided metal-roofed shed w/ overhang and 5' doors at ~\$2800 including delivery + \$600 for site prep, and 2) 8'x13' Suncast resin shed w/ windows, ventilation, double doors, integrated floor, and 10-year warranty at \$1599 + site prep (modular interior accessories and shelving available); Free delivery or pick-up (depending on where purchased)
- Linda and Kim have permit paperwork from Kent County to complete; Bob Hodge as property owner must sign permit
- All-in costs should not exceed \$2500
- · Linda, Ed, and Don will finalize recommendation to Board

Piling Donut Disposal (Kim)

- Create Marketplace ad in August/September to try to sell used piling donuts (not as successful for our Boat Dock as 'noodle' piling collars); Cost to make = \$55 each
- Offered donuts to Shorewood Estates waterfront residents (no interest); Dispose of unwanted 'donuts' if Marketplace ad is unsuccessful
- Offer Bob Hodge 8 new never-used donuts; Add to Marketplace if Bob is not interested; Ask neighbors along Sassafras River and at Gregg Neck
- Kim or Don will create Marketplace ad; Linda will contact Bob Hodge and offer donuts

Beach Sand / Kent County Site Plan (Kim)

- Adding more sand to Beach is non-compliant w/ environmental regulations; Sand washes off Beach into Sassafras River / Swantown Creek creating water quality and wildlife issues
- Need to create site plan for Beach, Boat Dock, and Pond areas; Site plans can be registered and monitored
- Investigate whether land where reeds are growing east of sandy Beach area could be recovered to expand Beach
- Walking path exists part way around pond (up to area near last property on Mallard Lane) but is overgrown;
 Add to site plan and create fall/winter project to clear path (when poison ivy, etc., die off); Obtain approval from property owners Bob Hodge and Bob Stevenson
- · Create site plan

Boat Dock Slip Expansion (Don)

- Phase 3 (rebuilding/raising T-pier level) scheduled for February 2021
- Consider expanding Boat Dock by adding at least 2 slips; Could add another slip w/out a finger-pier access (less costly to build and seasonal Slip Dues for that slip would be less)
- Slip Lottery requests for deeper water slips are greater than shallower water slips; Consider expanding dock out past current T-pier, then add T-pier at end of dock extension, or add one slip on each end of existing T-pier
- Kim will obtain proposal and quote for extending T-pier, adding slips, and permitting from Mark McCool

Boat Dock Ladder (Kim)

- Currently, there is no ladder at Boat Dock; Jeff Russell had talked about obtaining/installing ladder
- Kim will confirm w/ Jeff about boat dock ladder

Boat Launch Site (Kim)

- Consider installing mooring balls and floating dock next to launch area so launched boats can be temporarily secured while car and trailer are being moved
- Consider moving storage racks (closer to Pond?) to allow more area for better maneuverability when launching and hauling boats
- Research Boat Launch area at end of access road to Boat Dock; Develop site plan to create better launch area as primary launch site (no launching at Beach)
- Linda will contact resources from UMD Extension Services and Stormwater Mngt Planner for assistance and potential for grant funding

Pond and Tree Issue (Kim)

- Tree stripped of branches is an eyesore and possibly dying; Branches cut from tree need to be removed from Pond (Clean-Up task)
- Site plan should include addressing algae issue in Pond; Barley straw could be a solution (order this year for next year supply)

Road Signs – Shorewood Rd and Wilson Point Rd (Don)

- Road signs missing = Airfield warning sign, 40MPH Speed Limit, Pineywood Rd (private road); Contact County to replace speed limit sign on Wilson Pt Rd
- Bryan will contact Phil Parrish about whether no airfield warning sign on Shorewood Rd is a safety concern for him
- Don will contact County about speed limit sign on Wilson Pt Rd

Shorewood Estates Speed Limit (Don)

- County planned to conduct speed study in neighborhood but postponed due to COVID-19; Consider posting speed-reader sign, or planting ornamental trees to 'narrow' the road to reduce speed, or painting speed signs on road
- · Unsure whether speeding is still an issue; Most think visitors and contractors, not residents, speed
- Don will investigate speed-reader sign and contact county about speed test

Community Maintenance and Improvement Plan (Kim)

- Create plan to present to Membership at next Annual Meeting; Include budget and all common areas, e.g., Pond, Beach, Boat Dock; Solicit project ideas from Membership
- · Identify project categories and earmark Dues or raise funds for each project
- Create 5-Yr Maintenance and Improvement Plan; Investigate IRS rules about fund-raising for common area improvements

Community Events Status

- COVID-19 guidelines will determine how and when we can schedule and gather
- TLT postponed indefinitely; Jazz Band outdoor concert postponed until at least Sunday, September 20 (waiting for date confirmation from Jim Pileggi)

New Business

- Bob Hodge cleaned-up brush area near airfield
- Don received suggestions from several neighbors Install fire-pit and 'campground-style' grill at Beach; Install fixed structure at Beach for shade
- Create neighborhood committee to investigate siting, costs, funding, permitting, etc.
- Don will contact Jeff Russell about available wood at brush area near airfield for his shoreline project
