Sri M. Thambi Durai [AIADMK] has been appointed as the new Cabinet Minister for Law, Justice and Company Affairs.

KAT To Go

The state government has decided to scrap the Karnataka Administrative Tribunal with effect from August 1, 1998, pending central government's approval. Disclosing this to newspersons Mr. M.C. Nanaiah, the Law Minister, said that the decision to scrap KAT was prompted by the Apex Court's ruling of March 18, 1997 which rendered the Administrative Tribunal a superfluous institution. All pending cases would be transferred to the High Court. According to Mr. Nanaiah abolition of KAT will save Rupees Four to Five crores annually to the state exchequer.

Summer Vacation

KAT will be closed for summer vacation from 15th to 30th April 1998.

Lok Adalat Inaugurated

Chief Justice R.P. Sethi inaugurated the First Lok Adalat at the Karnataka High Court on 28-3-98. In his speech Justice Sethi pointed out that from 1-7-97 66000 pending cases have been disposed off by the High Court and it is proposed to reduce the pendency to zero level within a short time. Mr. Justice Y. Bhaskara Rao called upon the High Court Legal Services Committee to introduce more variety of cases for settlement during Lok Adalat. Mr. Justice A.J. Sadashiva. Executive Chairman of KSLSA, who spoke on the occasion appealed to the lawyers not to give up any opportunity available to them for settlement of disputes before the Lok Adalats.

Mr. Justice R:V. Raveendran, Chairman of the High Court Legal Service Authority welcomed the guests and also explained the back ground of the Lok Adalat being held at the High Court. Mr. R.I. D'sa, Addl. Government Advocate, proposed the vote of thanks.

Women Layers Get Addl. Accommodation

Women Lawyers have been allotted addl. accommodation in the City Civil Court premises to be used as waiting room. Accepting the plea of the women Lawyers, who have substantially grown in numbers. Mr. Justice Y. Bhaskara Rao allotted the addl. accommodation. Alternate accommodation is also allotted to the extension counter of the State Bank of Mysore functioning in the City Civil Court Complex.

Around the Courts

☐ Sec. 138 of the Negotiable Instruments Act. 1881-stop payment instruction, punishable:

Sec. 139 of the Negotiable Instruments Act. 1881-presumption in favour of the holder of a cheque:

In a significant judgment delivered on 8-3-98, three judge bench of the Supreme Court headed by Justice M.K. Mukherjee, has held that a person who gives stop payment instruction to his bank immediately after issuing a cheque against a debt or liability cannot escape prosecution. By this judgement the Apex Court has over ruled the earlier judgments of two judge benches which took a contrary. view in 1996.

The latest judgment states that "The propositions in both these judgments in our considered view, with great respect are contrary to the spirit and object of Sections 138 and 139 of the Negotiable Instruments Act. If we are to accept this proposition it will make Section 138 a dead letter, for, by giving instructions to the bank to stop payment immediately after issuing a cheque against a debt or liability, he can easily get rid of the penal consequences notwithstanding the fact that a deemed offence was committed."

The court held that once a cheque was issued by a person, a presumption under Section 139 that he had received the cheque in whole or in part of any debt or other liability must follow. Merely because the person issuing the cheque gives a notice to the holder or to the bank for stoppage of payment would not preclude an action under Section 138 by the holder of the cheque in due course.

Whether Consumer Forums

Can Enforce their orders?

In Writ Petition No. 20067/
1994 filed by Vishwabharathi House
Building Co-operative Society Limited,
the Division Bench of the Karnataka
High Court by its Order dated 194-1995, ruled that the Orders
passed by the District Forum,
Bangalore, cannot be enforced under
Section 27 of the Consumer
Protection Act, 1986. The Union of
India and the State of Karnataka did
not challenge this order before the
Hon'ble Supreme Court and hence the
said Order became final and binding
on all the Consumer Forums in India.

In another writ petition No. 23455/1994 filed by the said Vishwabharathi House Building Cooperative Society Ltd. the Division Bench of the Karnataka High Court by Order dated 19-4-1995 ruled that the Consumer Forum cannot directly enforce its orders invoking Section 25 of the Consumer Protection Act, 1986. The State of Karnataka though challenged this Order before the Hon'ble Supreme Court of India, New Delhi, in Special Leave Petition (Civil) No. 20251/1995 and sought for an Interim Order of stay of operation of the said Orders passed in writ petition No. 23455/94, the Hon'ble Supreme Court, by Order dated 18-9-1995 summarily rejected the application for stay.

Under the prevailing circumstances, that too when the Apex Court declined to grant stay sought by the State of Karnataka, Consumer Forums in India cannot enforce their Orders either under Section 25 or under Section 27 of the Consumer Protection Act, 1986.

- On 7-3-98 H.E. the Governor of Karnataka Mr. Khurshed Alam Khan, inaugurated the Golden Jubilee Celebration of the University Law College, Bangalore. Mr. Justice R.P. Sethi, the Chief Justice of High Court of Karnataka presided over the function.
- Attributing part of the delay in dispensation of justice to lack of facilities Mr. Justice M.F. Saldanha called upon the private sector entrepreneurs, MNCs and other organisations to provide infrastructure upgradation in courts. Justice Saldanha was speaking at a symposium on "delay in dispensation of Justice a national crisis" jointly organised by the NLSIU and Indian Institute of Legal Literacy at Bangalore on 30-3-98.

The judges said the penalties for dishonoured cheques contained in Sections 138 to 142 of the Act was to promote the efficacy of banking operations and to ensure credibility in transacting business through cheques.

D Sec. 2(d) of The Consumer protection Act, 1986-parents of a child which suffered permanent brain damage are entitled to separate compensation and they are also consumers under the Act:

In a landmark judgment delivered on 26-3-98 the Supreme Court held that the parents of a child which had suffered permanent brain damage as a result of negligence by the staff of a private hospital were entitled to separate compensation as they were also consumers under the Act. The bench comprising Justice S. Saghir Ahmad and Justice J.B. Pattanaik, in their 26 page judgment, held that "When a young child is taken to hospital and is treated by a doctor the parents would come within the definition of consumer having hired the services of the hospital and the young child would also become a consumer under the inclusive definition being a beneficiary of the statute."

The court dismissed an appeal filed by the Spring Meadows Hospital, Noida, against the order of the National Consumer Disputes Redressal Commission awarding a compensation of Rs. 12.5 lakhs to the minor child Harjot Ahluwalia besides Rs. 5 lakhs to the parents Harpreet Ahluwalia and Kamaljit Singh Ahluwalia, residents of Delhi.

Role of Lawyers Fast Changing

The role of lawyers is fast changing in the present judicial system and the lawyers are attempting to assume the role of litigants rather than playing the role of intermediary between the court and the litigants said Justice Manmohan Singh Liberhan, the Chief Justice of Madras High Court. Delivering the key note address on the role of lawyers at Salem on 9-3-98 organised by Salem Bar Association the Chief Justice said that securing the success of cases by wrong ways was becoming the order of the day which would eat away the routes of the judicial systems.

Boycott of courts was done at the drop of a hat making the poor litigants suffer, he said. He also pointed out that attempts were also made to browbeat judges/judicial officers by making allegations against them, insulting senior members of the bar etc., He appealed to the lawyers to present the case of their clients' in a dispassionate manner to reach the truth and help in reducing the arrears.

High Courts asked to Reduce Arrears

The Apex Court has asked the High Courts in the country to bring down the pendency of cases to 1990 level according to a recent circular. The Supreme Court hopes that the High Courts will be able to achieve this target before the closure of courts for summer vacation of 1998. Speaking at the inauguration of a lokadalat in Chennai the Madras Bar Association president Mr. P. Ravindran disclosed this.


News Panorama

- ☐ 34 advocates had contested to the 12th loksabha elections from Tamil Nadu out of which 20 advocates have been successful.
- Day businessman and a black cat cost a Gujarati newspaper form London Dollars 3,70,000 as compensation. Mr. C.B. Patel, editor Gujarati newspaper, its editor and publisher Garavi Gujarat that a certain article published in the latter newspaper had defamed him. The all-white jury of 8 men and 4 women unanimously uphell the plan of Mr. C.B. Patel.
- Ram Shri, 37 became the first women to be setenced for capital punishment [hanging till death] in independent India alongwith her father and brother who have been convicted of murdering her aunt, her son and daughter-in-law. Ram Shri is lodged in Mathura jail [UP]. However, the Apex Court has stayed the sentence on an appeal filed on behalf of the convicts.
- A Srilankan Court fined Mr. Welikadage Don Saminda, a 24 year litigant who appeared in Court wearing a T-Shirt that carried the picture of a couple kissing passionately. The Court also ordered for confiscation of the T-Shirt after holding the wearer of having committed contempt of Court.
- A Pakistani judge directed the suspension of the Lahore Air Port Manager for delaying a flight awaiting the arrival of the Prime Minister Nawaz Sharif's son. An aide of the sonstruck PM intervened to have the suspension of the Manager revoked.
- Singapore has become the first country in the world where an attempt has been made to incorporate a new clause in the divorce law. According to the new law Singapore couples will soon have to decide between themselves who gets their property before the divorce case is filed. The law is intended to spare families the emotional pain and legal costs of fighting over their homes after they are divorced.
