Judges Sore

Members of the subordinate judiciary throughout the country are sore after the Fifth Pay Commission enabled the court staff to draw higher salaries than the Judges. It is learnt that the First National Judicial Commission constituted in March 1996 to examine the structure of emoluments and conditions of services of judicial officers has been handicapped is not being able to award any interim relief to the Judges as the terms of reference of the Commission does not empower to-make any such recommendation.

Govt. To Repeal Land Ceiling Act

The Union Cabinet which met on 13-11-97 decided to repeal the Urban Land [Ceiling and Regulation] Act, 1976 setting the stage for a sharp fall in land prices across the country and faster growth in construction activities in 64 cities which come under the purview of the Act.

SC Hearing

Writ petition presented under Article 32 of the Constitution of India and the connected special leave petitions challenging the validity of the rule prescribing pre-enrolment apprenticeship for law graduates is scheduled to be heard by the Supreme Court on 9-12-97.

Vacations - 98

Through a Notification dated 22-11-97 the Karnataka High Court has notified that the Civil Courts in the State will be closed for vacations as specified below during the year 1998. Summer Vacation:

20-4-98 to 24-5-98 b.d.i. Dasara Vacation : 28-9-98 & 29-9-98 Winter Vacation : 21-12-98 to 1-1-99 b.d.i.

SC cannot probe its Judges Misconduct

The Supreme Court has no parallel jurisdiction to that of parliament to probe charges against its own Judge. The reported action of the Chief Justice of India in appointing a Judges' Committee to inquire into allegations against Justice M.M. Punchhi was Unconstitutional, says the Bar Association of the Supreme Court. The Association adopted a near unanimous resolution to this effect at its general body meeting held on 10-11-97. The Association said that "The only option at this stage will be to leave it to constitutional procedure applicable in matters of this nature as reflected in Article 124 [4] and [5] of the Constitution of India. Any other procedure evolved either through in-house proceeding or otherwise is unconstitutional". Significantly the resolution also said that a perusal of the allegations made by the Committee on Judicial Accountability against Justice Punchhi, tipped to take over as the next Chief Justice are ex-facie frivolous, untimely merit no compideration and have the appearance of being motivated.

Police Unaware of Copy Right Act - Ribeiro

Most of the police personnel are unaware of laws concerning intellectual property rights and therefore the Copy Right Act was not being properly implemented said Mr. J.F. Ribeiro, the former Punjab Director General of Police. He was speaking to media persons at Bangalore on 7-11-97. Mr. Ribeiro said that wars in 21st century will be fought over economic issues and intellectual property rights and if the police are not geared to tackle such white collar crimes developing nations like ours would suffer. Regarding IPR violations in the music industry he said the industry would be killed if pirates take over. He also pointed out that the Rs. 900 crore market in the country with regard to audio cassettes is hit by the pirated cassettes to an extent of 40 percent.

Around the Courts

The Haryana Panchayati Raj Act -Right to contest election to the post of Panch or Sarpanch is not fundamental right:

A Division Bench of the Punjab and Haryana High Court comprising Justices Amarjit Chaudhary and V.C. Aggarwal upheld the provisions of the Haryana Pachanyati Raj Act which bars a person from holding the office of Panch or Sarpuch if he or she has more than two children. The judgment delivered on 11-11-97 has held that the right to election is not a fundamental right and reasonable restrictions based on economic and social factors may be imposed.

The writ petition challenging the provisions of the Act had been based on the ground that (a) there is no such restriction in the Representation of Peoples Act (b) that it was opposed to Muslim personal law. While holding that the legislation did not interfere in the personal right of Muslims to practice or propagate their religion it had been brought by the state as a special law and it applies to all persons irrespective of their caste or religion.

The Bench observed "The Government, in order to check the population growth, has introduced various projects to implement family planning which have been entrusted to various agencies, one of which is the gram panchayat. It is expected from the panchs and sarpanchs to set good example and they are supposed to maintain the norm of two children. If they themselves violate the same, what examples can they set before the public?"

The Armed Forces (Special Powers) Act, 1958 - Constitutional validity upheld:

A Five Judge Constitution bench of the Supreme Court comprising the Chief Justice J.S. Verma, Justices M.M. Punchhi, S.C. Agarwal, A.S. Anand and S.P. Bharucha upheld the

Constitutional validity of the Armed Forces [Special Powers] Act, 1958 but emphasised that the list of "do's and don't's" given by the Attorney General should be treated as "binding instructions which are required to be followed by the members of the armed forces in exercising powers under the Act." The Court held that a) declaration has to be for a limited duration and; b) there should be a periodic review of the declaration before the expiry of six months.

The judgment dated 27-11-97 rejected a petition filed by the Naga Peoples' Movement of Human Rights which had challenged the Act. The Court ruled that the powers given to the armed forces under the Act were not "unreasonable or arbitrary."

Appointment of Addl. Advocate General - Is a Brahmin not entitled:

In a judgment dated 12-11-97 Justice E. Padmanabhan of Madras High Court held that there can be no bar for appointment of a Brahmin as Addl. Advocate General of Tamil Nadu. While dismissing a writ petition filed by the president of Periyar Dravidar Kazhagam challenging the appointment of T.R. Rajagopalan to the post of Addl. Advocate General The Court held that there cannot be a bar for appointment of a Brahmin to the constitutional post. The petitioner had contended that the ruling DMK pursuing the ideals of rationalist leader Periyar E.V. Ramaswamy Nayagar, could not have appointed a Brahmin to the said post. The Judge pointed out that no material had been placed to show that the DMK had proclaimed that it was against and it would never appoint a Brahmin to any post or office. The Judge also pointed out that even if the petitioner's contention could be assumed to be correct it cannot stand the test of law without violating the constitutional provisions. Any such restriction will be per se unenforceable

Judicial officers in Bihar went on a strike on 19-11-97 protesting against the attack on the additional Sessions Judge, Bhagalpur, by the local police. The police present in the court assaulted the Judge besides ransacking the court hall. They were enraged by the order of the Judge sentencing a Sub Inspector of Police to undergo jail term in a contempt case. Shaik Kasim and a large number of Advocates remembered Prof. Janardana and his contribution to the legal fraternity.

SC rejects BDAs sital value enhancement

The Supreme Court of India, by its land mark decision dismissed all the 108 Special Leave Petitions filed by B.D.A. on 13-10-1997 upholding the judgement of the Division bench of Karnataka High Court comprising Chief Justice R.P. Sethi and Justice S. Rajendra Babu and further holding that it finds no reason to interfere with the judgment and order dated 10-1-1997.

It may be recalled that B.D.A. had arbitrarily enhanced the sital value from Rs. 55,000/- to Rs. 2.52 lakhs of various sites long after the petitioners were intimated the allotment of sites, in exercise of their power under Rule 12 of B.D.A. Rules, 1984 which was challenged by the petitioners contending that the upward revision of sital value amounted to hostile discrimination, violative of Article 14 of the Constitution of India. The petitioners had further contended that B.D.A. had no powerto enhance the sital value after notification and calling for applications and as such, they sought for a declaration of Rules 12 of B.D.A. Rules, 1984 invalid and questioned the legality and constitutional validity of enhanced sital value which was allotted earlier.

The High Court held that the resolution passed by the BDA under subject 235/92 on 19-12-92 and consequent notices of enhancement issued to the allottees were discriminatory and violative of constitutional guarantee. But declined to hold that Rule 12 of the BDA Rules were discriminatory or violative of Constitution.

The Court declared the notices issued to the allottees as illegal and void even while holding that the sital value fixed by the BDA was commensurate with the prevalent situation as on 8-9-1989 i.e. the date of allotments. The court directed the BDA to hand over the sites to the allottees after completing all the developmental activities strictly according to the scheme within three months positively.

HC Direction on Demolition

By its order dated 7-11-97 the Karnataka High Court has directed the Bangalore City Corporation to remove the shops, Banks and other structures in the basement floor of Manipal Centre on Dickenson Road, Bangalore and provide space for parking vehicles therein. While allowing the PIL filed by nine residents of Ulsoor Road and Yellappa Chetty Layout. Justice C.N. Aswathanarayana Rao, in his 236 page judgment, also directed the officials of BCC to ensure a set back area of 16 meters on all sides of the building. The Court held that the constructions in the basement of the building have been done in violation of Rule 21.1. (a) and (b) of the Bangalore Muncipal Corporation Building Bye-laws. The Court granted four months time to complete the task assigned to it.
