



# Equipment Rental Agreement

This Equipment Rental Agreement (“Agreement”) is made and entered into as of \_\_\_\_\_[Date], by and between \_\_\_\_\_[Renter Name] (“Renter”), and The Party Plugz (“Owner”).

1. Equipment. Owner agrees to rent to Renter, and Renter agrees to rent from Owner, the following equipment, which is identified by its unique serial numbers.

## 1. Term:

## 1. Rental Payments:

Renter shall pay Owner rental fees in the amount of \$\_\_\_\_\_ per [Day/Week/Month], payable in advance, for the Rental Term. In the event of any late payment, Renter shall be responsible for all costs of collection, including reasonable attorney's fees.

**1. Use of Equipment:**

Renter agrees to use the Equipment in a careful and proper manner and to comply with all applicable laws, rules, and regulations regarding the use of the Equipment. Renter shall not permit the Equipment to be used by any unauthorized person or for any unlawful purpose.

**1. Prohibited:**

Renter agrees to the following: shoes MUST stay out of bounce house. No rough housing to the best of your abilities.

**1. Maintenance and Repair:**

Renter shall maintain the Equipment in good condition and repair during the Rental Term. Renter shall be responsible for all ordinary maintenance and repairs of the Equipment, except for repairs necessitated by normal wear and tear, in which case Owner shall be responsible for such repairs.

**1. Loss or Damage to Equipment:**

Renter shall be responsible for any loss of or damage to the Equipment during the Rental Term, whether caused by Renter or any other person. Renter shall immediately notify Owner in the event of any loss of or damage to the Equipment and shall pay Owner the reasonable costs of repair or replacement.

**1. Insurance:**

Renter shall maintain comprehensive general liability insurance covering all activities conducted by Renter and all persons using the Equipment during the Rental Term, with limits of liability not less than \$\_\_\_\_\_ per occurrence. This falls under the Renter's Homeowner Agreement.

**1. Indemnification:**

Renter shall indemnify and hold harmless Owner, its officers, directors, employees, agents, and affiliates, from and against any and all claims, damages, losses, and expenses arising out of or in connection with Renter's use of the Equipment, including but not limited to any claims arising out of personal injury, property damage, or breach of any applicable law.

**1. Ownership:**

The Equipment shall at all times remain the property of Owner, and Renter shall have no right, title, or interest in or to the Equipment except as expressly set forth herein.

**1. Default.**

If Renter breaches any provision of this Agreement, Owner may terminate this Agreement and retake possession of the Equipment without notice or demand, and Renter shall be liable for any damages resulting from such breach.

**1. Governing Law:**

This Agreement shall be governed by and construed in accordance with the laws of the state of Illinois, without giving effect to any choice or conflict of law provision or rule.

**1. Entire Agreement:**

This Agreement constitutes the entire agreement between the parties and supersedes all prior or contemporaneous agreements or representations, whether oral or written, relating to the subject matter of this Agreement.
