

CHANGE / CANCELLATION POLICY

Cancellations must be made two weeks (14 days) prior to your reserved date or you will be responsible for the FULL amount of services agreed, according to this contract, at the current rate that these services are priced. Any cancellation will be liable to loss of deposit.

In the event of natural causes: Sickness, accidents, acts of God, natural disaster or travel disruptions, I take responsibility in helping you find replacement artists at no cost, from me, to you.

Changes to bridal party must be made up to 2 weeks (14 days) prior to booking date. Any changes (removing services) after that will result in the full payment of original booking services. Changes of adding services will be discussed if artists have time available and resources to make it work.

PAYMENT TERMS




A non-refundable booking fee of \$150 is needed prior to booking the date of wedding. This fully secures your date being locked in!
