Vendor and Sponsor Terms and Conditions

1. Event hours

- Friday June 23RD, Vendor meet and greet
- Saturday June 24th, Public Event
- Sunday June 25th, Public Event

2. Vendor set up and tear down

Vendors must check-in at DHA booth between 6:00am and 8:30am on Saturday June 24, 2023 where they will be directed to their assigned vendor space. Set-up must be completed by 9:00am and support vehicles moved to assigned parking. Vendors can check-out of their spaces beginning at 4 pm Sunday June 25 and are required to ensure their space is reasonably clean and free of waste or leftover debris before vacating. Vendor times are as follows:

- June 23^{tRD} set up for large booths or events ONLY (not public)
- June 24th 9:00am to 6:00pm (public)
- June 25th 9:00am to 4:00pm (public)

3. Booth specification

Booths will be allocated by the organizers throughout the event site. Organizers will not provide tents. Location of the vendor booth is at the discretion of the Vendor Organizer.

4. Power

The Vendor Organizer must be notified if the vendor requires electricity on the Vendor and Sponsor Registration Form.

5. Indemnity and Insurance

The vendor shall from time of take-over of the rented space provide proof of Public Liability /

Property Damage Insurance with the Devil's Half Acre as an additional named Insured stated on the insurance form or Contract until such time as the rented space is returned to the organizer. The Devil's Half Acre Motorcycle Event is not responsible for security, loss of profits, product, and bodily injury to staff or volunteers.

6. Vendor Identification

Vendors will be provided with identification that is the proof of registration for their booth. Vendors must show this identification during the event.

7. Parking

Vendors will be provided prior to the event with a parking map of the site. Unauthorized parking will result in removal of vehicle(s) at the expense of the vendor.

8. Removal
