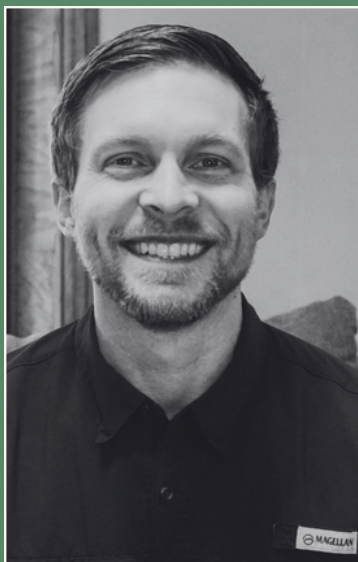


## *Ruth Wisher*
