- 4. Committee Reports:
  - a. Architectural Review Committee (ARC) Greg Dix presented 2 new roofs and one new build approved by ARC committee in the past two months. Kim Nichols made a motion to nominate Bill Phillips as Chairman of the ARC Committee; Peter Wagner seconded, and with all in favor, approved.
  - b. Welcome Committee Marta Donovan presented 1 new homeowner moved into Alpine Heights within the past month and was given binder/website information.

- 5. Old Business
  - a. Board Officer transition update: banking information and historical information transitioned to the new board.
  - b. Website Update: Kim Nichols presented payment for website is now every two years.
  - c. Committee Discussion: forming new committees to increase participation of members.
    - 1. Declaration of Restrictions (D of Rs) Review Committee
    - 2. Spring Picnic Committee
    - 3. Garage Sale Committee annual event (reminder AHHOA restricts individual garage sales throughout the year).
    - 4. Communications Committee: roster maintenance, newsletter, emails, and website.
    - 5. Firewise Committee needs volunteers to assist in cleaning up lots in need within the AHHOA.
  - d. Sandwich boards to increase communication of upcoming events with our members.

- f. Mirror on Alpine Heights Road limited sight curve Town Engineer (Traffic Control) stated they do not fund safety mirrors and any privately paid mirrors cannot be placed in the right of way. Yellow traffic road signs of "15 mph" and "limited sight distance" are already posted. Alpine Heights is requesting to be on the list for a temporary digital speed monitor near this limited sight curve.

g. HOA Management Company – benefits of hiring a financial management company for the AHHOA, instead of relying on bookkeeping volunteers within the AHHOA. Discussed legal representation - Halk, Oetinger and Brown, PLLC.

1. Kim Nichols made a motion for the AHHOA to pay a \$50 per month retainer fee for the legal services of Halk, Oetinger and Brown, PLLC. Sue Sample seconded, and with all in favor, approved.

2. Community Accounting, LLC for the financial management of AHHOA (monthly cost ranging from \$250 - \$500) - tabled until the next board meeting.

- 3. Decision for contingent fee agreement with Halk, Oetinger and Brown, PLLC for the collection of Delinquent Assessments & Legal Representation- tabled until next board meeting.
- h. Lot 147 Update: We believe we are close to reaching an understanding with the Town of Payson without the need for collecting a community assessment from our HOA members. However, we need a conclusion with Tayco first.
