 Community Comments: Two community members presented safety concerns regarding Lot 161 renters speeding motorcycles within our community.
 One community member filed a report with the Payson Police regarding this matter and vandalized landscape lights. Board members encouraged members to continue to report ongoing safety concerns to the Payson Police.
 Lance Marble responded he met with the Payson Chief of Police and requested a speed monitor within our community. The rental management representative of Lot 161 has been notified of the issues and the Town of Payson code, Chapter 131: Disruptive Properties.

- 2. Approval of Minutes for February 6, 2024 Board Meeting: Lorian Roethlein made a motion to approve the minutes of the February 6, 2024 Board Meeting. Sue Sample seconded, and with all in favor, the motion was approved unanimously.

In addition, online voting for our annual Board election will also be offered, along with the traditional paper ballots. Cindy Junkert (Treasurer) was thanked for her voluntary services to the association and will continue her voluntary service to monitor the accounting processes and work of our professional management company.

  - d. Declaration of Restrictions (D of Rs) Committee reviewed the AHHOA Declaration of Restrictions 2020 and concluded no major changes needed, only typographical error corrections, permitted under the scrivener's error. Quorum will be corrected as 50% plus one of the membership (instead of those voting). The committee recommends a comprehensive review in 2025-2026 with any updates requiring membership approval.
