He is Professor of Defence Studies and Chair of the Department of Security and International Affairs, Canadian Forces College, Toronto, Department of War Studies, Royal Military College of Canada, Kingston, Canada. Prof. Dorn's research focus is on UN peace operations, the ethics of armed force, the United Nations, and arms control. In 2006, he was commissioned by the UN to conduct a study on technology for peacekeeping.

Dr. Juyal is a former Dean of International Studies and Distinguished Professor of International Law and Political Science of Himgiri University of India, and Full Professor of Political Science and Director of the Institute of United Nations and International Affairs. He is currently, Senior Research Scholar at the Atlantic Human Rights Centre of St. Thomas University, Chairman of the WFSW International Commission on Nuclear Disarmament, and a Consultative Status "A" Observer, at the United Nations ECOSOC. Prof. Juyal has been biographed in Canadian Who's Who, and America's Who's Who.

Dr. Karen Feste is Full Professor and Founder & Director of the interdisciplinary Conflict Resolution Institute in the Korbel School of International Studies at the University of Denver, Denver, Colorado, USA. Served as Associate Dean, University Budget Director, and Director of the International Security MA program, she received her PhD in Political Science from the University of Minnesota, has been listed in Who's Who in American Women, and in 1980, was selected as an Outstanding Young Woman in America. She has been a Fulbright Scholar, and has published several books including: Plans for Peace: Negotiation and the Arab-Israeli Conflict; Terminate Terrorism: Framing, Gaming and Negotiating Conflicts; and America Responds to Terrorism: Conflict Strategies of Clinton, Bush, and Obama.
