SESSION CHAIRS, KEYNOTE SPEAKERS AND PRESENTERS

Dr. Kawser **Ahmed**, PhD is a graduate of the Defence Services Command and Staff College, Bangladesh with a MPhil in Peace and Conflict, the University of Dhaka, Bangladesh and a PhD from the University of Manitoba, Canada. Dr. Ahmed served in the Bangladesh Army, the Turkish Armed Forces and as a peacekeeper to the United Nations Missions for the referendum in Western Sahara (MINURSO). He is currently a SSHRC post-doctoral fellow in the University of Winnipeg, and Executive Director of Conflict and Resilience Research Institute Canada.

Mr. Mathias Awonnatey **Ateng** is a PhD Candidate, Peace Conflict Studies, University of Manitoba, Winnipeg. He holds a MA in Peace and Development Studies from the University of Cape Coast and he is with the University for Development Studies, Ghana as an Assistant Registrar.

Ms. Charlene **Doak-Gebauer** has developed a theory of digital supervision for child protection which is included in her book *Digital Sexual Victims: True Cases*. The book was nominated for an award by International Educators. She is the Founder and Chair of the Canadian charity Child Pornography Hurts. Her studies began at the University of New Brunswick where she obtained her Bachelor of Education (Business). She studied Computer Science at the University of Western Ontario where she earned the equivalent of a Bachelor of Business Administration (Honours). She was then accepted to the University of Toronto to complete her Honours Business Specialist qualification. She has studied several network management courses and managed computer networks, the largest of which had 250 computer stations. Charlene is a qualified secondary school educator and a Registered Holistic Nutritionist.

Dr. Walter **Dorn**, PhD, is Professor of Defence Studies at the Canadian Forces College and at the Royal Military College, Kingston. A scientist by training (Ph.D. Chemistry, University of Toronto), his doctoral research was on chemical sensing for arms control. He assisted with the negotiation, ratification and implementation of the Chemical Weapons Convention. His interests are broader now, covering international and human security, especially peace operations and the United Nations (UN). A. Walter Dorn is the author of *Air Power in UN Operations: Wings for Peace* (Ashgate, 2014); *Keeping Watch: Monitoring, Technology and Innovation in UN Peace Operations* (United Nations University Press, 2011) and the editor of *World Order for a New Millennium: Political, Cultural and Spiritual Approaches to Building Peace* (Palgrave Macmillan Press, 1999) Dorn has extensive experience in UN field missions. He served as a district electoral officer with the United Nations (UN) Mission in East Timor in 1999; in Ethiopia on a UNDP project; and at UN headquarters as a Training Adviser with the UN's Department of Peacekeeping Operations (DPKO). He was on the UN's Panel of Experts on Technology and Innovation in UN Peacekeeping in 2014. He

served as the Innovation and Protection Technology Expert within the UN's Department of Field Support in 2017-18, providing advice to improve UN missions in the Middle East and Africa including Lebanon, the Central African Republic, the Democratic Republic of the Congo and Mali. He has served as the UN Representative of Science for Peace, a Canadian NGO since 1983. He is the President of the World Federalist's Association, Ottawa and the Past Chair of the Canadian Pugwash Group (2015-17, 2017-19). He was a Senior Research Fellow at Cornell University (1998-2000); a consultant to Yale University (1996); a visiting scholar at the Cooperative Monitoring Centre (1999) and an adviser to the Federation of American Scientist's Biological Weapons Control expert group (1990). At the University of Toronto, he was a Research Fellow with the International Relations Programme as well as the Peace and Conflict Studies Programme, and he was the Physical Science Don at Trinity College.

Dr. Parin **Dossa**, PhD, Full Professor of Anthropology, and Associate Member, Department of Gender, Sexuality and Women's Studies, Simon Fraser University, British Columbia, Canada. She is a Member of the Advisory Board of *Anthropologica*, the Journal of the Canadian Anthropology Society; Co-editor of *Transnational Aging and Reconfiguration on Kin Work* (Rutgers University Press, 2017); Author of the following books: *Afghanistan Remembers: Gendered Narrations of Violence and Culinary Practices* (University of Toronto Press, 2014); *Politics and Poetics of Migration: Narratives of Iranian Women from the Diaspora* (Canadian Scholars Press, 2004). Dr. Dosa's ethnographic research on Muslim women in the diaspora has resulted in several interrelated projects: Racialized bodies and the disabling world; Policy implications of storytelling; Politics of displaced care; Testimonial narratives and social memory, Social suffering, Violence in war and peace. Her work has been published in *Medical Anthropology Quarterly*; *Social Science and Medicine*; *International Journal of Mental Health*; and, *International Journal of Rehabilitation Research*.

Dr. Rose **Dyson**, Ph.D. Ed.D. (Ontario Institute for Studies in Education, University of Toronto) is the author of *MIND ABUSE Media Violence in an Information Age* (2000) and the co-author of 11 other peer-reviewed books. She was the editor for 17 years of *The Learning Edge* (Canadian Association for the Study of Adult Education). She was the associate editor of *Peace Issues in the 21st Century Global Context*, eds. John Duncan, Shreesh Juyal (UK: Cambridge Scholars Publishing, 2017). She is the President of Canadians Concerned About Violence in Entertainment and Chair of the National Advisory Council of the Canadian Peace Research Association (2013-15, 2015-17, 2017-2019). She is a member of the Climate Action Network, the Global Ecological Integrity Group, and Just Earth. She is also the Director of Communication and a member of the World Federalist Movement, Toronto Branch, Canada.

Dr. Noemi **Gal-Or**, PhD, LL.B. (PhD, IUHEL, Geneva), LLB (UBC, Vancouver); retired Full Professor of Politics and International Law, Kwantlen University, B.C.; formerly,

practicing lawyer and Chair, IL Section of the Canadian Bar Association, and Editor-in-Chief of its journal, *Canadian International Law*; formerly, Research Director of the International Law Association (ILA)-Canada, and board member, International Association of Jewish Lawyers. Dr. Gal-Or has published extensively in various areas including international law (trade and investment, dispute settlement, responsibility, anti-corruption, humanitarian, human rights, criminal law, and the non-state actor's status), international organisations (UN, WTO), international political economy, regional integration (EU, NAFTA, draft FTAA, TPP): security, terrorism, conflict resolution, public policy, migration, and gender.

Mr. Peter **Genger** a scholar and practitioner in Peace and Conflict Resolution and inter-cultural dialogue. He holds an MEd in Inter-religious Dialogue (Boston College), an MA in Peace and Conflict Studies (PACS) (University of Manitoba) and he is a PACS PhD Candidate at the same university. His areas of research include Indigenous Peacemaking; mainstreaming the African and Indigenous Peacemaking Approaches (AIPA); critical Indigenous research, decolonization, indigenous knowledge and pedagogy; conflict transformation, restorative justice, Inter-cultural dialogue; and world religions in search of community and peace.

Dr. Daniel **Goldstick**, PhD (Oxford University) is a Canadian philosopher, writer and Professor Emeritus at the University of Toronto. He received his BA from the University of Toronto and his B.Phil and D. Phil from Oxford University. His work focuses on metaphysics and epistemology including approximately 75 papers in *American Philosophical Quarterly*, *Explorations in Knowledge, Philosophy and Phenomenological Research*. He is the author of *Reason, Truth and Reality*. He is a supporter of the Canadian Peace Alliance and a longtime member of the CPRA. He is the founding editor of the Communist party's theoretical journal, *The Spark* and a longtime communist candidate in parliamentary elections for the Rosedale district in Toronto.
