**RE: Request for Urgent Meeting as to Miscarriage of Justice in Oklahoma Court System from Corruption I am Investigating, Involving Upright Mexican Citizen / Permanent Resident Maria Del Rosario Chico–Tulsa CF-2022-121, PO-2021-3316 and Related Cases**

Dear General Drummond,

I am contacting you to arrange an expedited meeting to discuss what I see is a questionable prosecution by a Tulsa County DA against an outstanding Mexican national living in Oklahoma named Ms. Chico. *The Tulsa DA appears to have met privately (ex parte) with a judge and zealous guardian ad litem who used to work at DHS, to orchestrate charges against Ms. Chico for missing court in a protective order case where she was the Plaintiff (Ex. 2), to have her arrested in a domestic violence shelter in Arkansas while protecting her children.* I am told the zealous GAL is under scrutiny for a pattern of unethical conduct including forging signatures in a probate case, and that opposing attorneys against Ms. Chico influenced witnesses not to testify (felony)(Ex. 3). I believe Mr. Kunzweiler's office, the GAL and a particular judge (Glassco) may have abused connections with law enforcement to issue a false narrative and questionable warrant of arrest for Ms. Chico for alleged indirect civil contempt in PO-2021-3316 *without any of the required state due process prior to order of arrest.* 21 OS 567.

Ms. Chico recorded (Ex. 1A-1B) DHS telling her to get emergency custody, which she got with a Protective Order, (still valid – PO 2021-3316)(Ex. 2). I am told Mr. Kunzweiler possesses the DHS recording (Ex. 1) but is still prosecuting her for *allegedly stealing her own children!* I heard Judge Glassco told Ms. Chico's attorney in the presence of a state witness he would not have ordered her arrest for indirect civil contempt if he had known the DHS recording existed! (Ex 1). I am concerned Mr. Kunzweiler has a handwritten letter from the zealous Guardian *ad litem* which he refuses to turn over in discovery. There are transcripts Tulsa County sealed which contain exculpatory evidence and proof of misconduct to have Ms. Chico falsely arrested (*ie.* September 26, 2023 transcript of Judge Hathcoat in case PG-2021-736 and others). Ms. Chico says the court system **is refusing to provide her access to transcripts in her own cases.** That sounds wrong. She provided me recorded proof DHS substantiated abuse to her children by the father (Ex. 1). Her act to go to the Mexican Consulate, then in Arkansas, and to an Arkansas domestic abuse shelter, with a Protective Order DHS encouraged, tells me this woman followed the law and protected her children *as state and public officials told her to do.*

I understand Ms. Chico's employer (DHS) (for whom she still works in light of child stealing charges) was contacted by the zealous GAL and judge Glassco (with whom GAL met privately *ex parte*), in what appears to be a conspiracy to influence DHS to change its finding of abuse, and sway the DA, Stephen Kunzweiler in Tulsa, to file felony charges against Ms. Chico for allegedly stealing her own children. **It appears the GAL took steps ex parte to retaliate through state court connections after Ms. Chico sued her in federal court.** The charge against Ms. Chico seems absurd and questionable.

Ms. Chico has an MBA, produced tv shows, and is the type of citizen Mexico should be proud of living in the US. I am concerned people in the DA office and a Tulsa County judge violated their oath of office to target and harm a citizen at the whim of a zealous GAL. Ms. Chico's case is similar to others I have seen, where retaliation occurred by abuse of the courts. I understand Ms. Chico and her criminal defense attorney have not received in discovery from Mr. Kunzweiler (the DA) the handwritten letter from the zealous GAL. *I feel Mr. Kunzweiler may be conflicted to prosecute the case, especially if his office performed the law enforcement investigation privately with a judge and GAL, received communications from them, yet refuses to turn those over.* I have also been given information that an attorney opposite Ms. Chico in the civil cases worked on Mr. Kunzweiler's campaign – again not passing a “sniff test” for Mr. Kunzweiler to be a neutral prosecutor in the case.

How does a civil court (Protective Order) issue a warrant of arrest for indirect civil contempt to a successful Plaintiff without any arraignment or showing what Order was violated and giving that person the opportunity to explain, in light of 21 OS 567? The Docket (Ex. 2) shows no due process. Why was Judge Glassco allowed to draft criminal charges directly with Kunzweiler against Ms. Chico without a law enforcement investigation and why hasn't Kunzweiler turned over all his communications with Judge Glassco, attorneys and the GAL in the civil cases?

*I am told a respected forensic child expert was in constant contact with the Tulsa DA since October 2021 as to Ms. Chico's acts to protect her kids, so Kunzweiler was aware there was no child stealing.*

Please let me know when we can schedule a brief urgent meeting to discuss. I am copying the Governor's office and the FBI.

I believe a proper investigation will demonstrate exculpatory evidence to dismiss Ms. Chico's case and should immediately be started to assess corrupt conduct – I am happy to help. I am attaching two recordings, one from DHS along with transcript (Ex. 1A, 1B), and one that indicates the attorney attacking Ms. Chico influenced a witness not to testify (a possible felony)(Ex. 3).
