

# Labette County Fairboard

## Fairground Facility Rental Rates

### Rodeo Arena

Includes the use of the arena, announcer's stand (with electric), timed event and rough stock chutes, livestock pens, spectator bleachers, and adjacent grass parking area. Water will be available during non-winter months.

Base Fee: \$125/Day

Arena Lights Fee: \$25/Night

Heated/Cooled Arena Restrooms: \$75/Day

- Standard City Ball Field restrooms are available (during non-winter months) at no charge, but are approximately 50 yards further from arena

Tractor Fee: \$75/Day

- The fee includes arena ground preparation prior to the event and arena leveling at the conclusion of the event each day. When needed, a tractor operator will be on standby and a \$5 Barrel Drag Fee will be charged each time the barrel pattern needs to be worked during an event.

\*\* The event organizer may make private tractor arrangements with the approval of the Fairboard \*\*

### Livestock Buildings

Includes the use of any (1) of the: Show Arena (including Goat/Sheep Barn), Beef Barn, Hog Barn, or Horse Barn. The use of any additional building(s) will be subject to an additional charge equal to ½ the primary rental rate. Electric and water (during non-winter months) will be available in each of the rented buildings. Electric is not allowed to be used as RV or trailer hookups. No vehicles are allowed to park within barns unless approved by Fairboard.

Free 4H/Youth Events: Damage Deposit Only

- Local 4H/FFA Events, Free Fitting/Showmanship Clinics, etc.

Other 4H/Youth Events: \$150/Day

- 4H Livestock Sales, Open Livestock Shows, Paid Fitting/Showmanship Clinics, etc.

Other Events: \$200/Day

- Auctions, etc.

Heated/Cooled Showbarn Restrooms: \$250/Day

- Main Areen Restrooms are available at the rate shown in this form but are approximately 100 yards further from the show arena and are only available in non-winter months.
- Standard City Ball Field restrooms available (during non-winter months) at no charge but are approximately 100 yards further from show arena.

\*\* Rate category determined at the discretion of the Fairboard. Multiple event dates may be discounted \*\*

**Facility Damage Deposit**

A damage deposit equal to the rental fee (or minimum of \$250) must be collected prior to any event that is held on the Fairgrounds. The event organizer will have (5) days from the completion of the event to return the facility to its original state. This will include but not be limited to: repairing facility damages, removing/replacing pens, removing bedding, and placing trash in receptacles. The deposit will only be returned to the event organizer after Fairboard verification of the facility condition. Failure to return the facility to its original state will result in forfeiture of the deposit. The Fairboard will inspect the facility (3) days after the completion of the event and notify the event organizer if the facility condition is not satisfactory.
