MODEL ORDINANCE ESTABLISHING FEES AND CHARGES

This model ordinance establishing fees and charges may be enacted by the City Council either at the time the Minnesota Basic Code of Ordinances is adopted or any time thereafter. It should be enacted in the same manner as any other city ordinance is adopted. AN ORDINANCE WHEREBY A SCHEDULE OF FEES AND CHARGES
FOR VARIOUS SERVICES, LICENSES AND PERMITS
FOR THE CITY OF WALDORF, MINNESOTA

Whereas, the City Council of the City of Waldorf will be adopting by resolution the Minnesota Basic Code of Ordinances as it has been amended and supplemented to be its city code and that code permits the city to adopt by resolution a schedule of fees and charges for various services, licenses and permits,

Now Therefore, the City Council of the City of Waldorf, Minnesota, ordains:

Section 1. All fees and charges in effect as of the date of the adoption of the city code for the city shall remain in effect unless otherwise modified by the provisions of a resolution. All citations below are to various sections of the city code unless otherwise indicated.

Section 2. The following are the fees and charges for the permits, licenses and services listed below which are referenced to the section of the city code which authorizes their establishment:

1. The monthly charge for water pursuant to ' 54.01 shall be \$72 base fee + \$.006/gallon
2. The monthly charge for sewer services pursuant to ' 54.01 shall be \$.00525/gallon
3. The charge for reinstating utility service and the turn-on charge pursuant to ' 54.03(C), shall be \$50
4. The charge for service disconnection and the turn-off charge pursuant to ' 54.03(C), shall be \$50
5. The charge for delinquent payments pursuant to ' 54.03(C), shall be 10% of the past due amount
6. The charge for water meters pursuant to ' 52.35(A)(1) shall be the cost of the meter + \$25
7. The rate due and payable for each user for water taken from the water system pursuant to ' 52.53(A) shall be \$0.10/gallon

8. The fee for Infiltration and Infrastructure non-compliant shall be \$100.00/month until compliant
9. The fee for a heavy load permit pursuant to ' 70.02(E) shall be \$0
10. The fee for an excavation permit pursuant to ' 93.25(A) shall be \$0
11. The fee for liquor licenses pursuant to ' 112.23(B) shall be on/off sale liquor licenses shall be \$250
12. The fee for a license as a peddler or a transient merchant pursuant to ' 113.03(D) shall be \$0
13. Fees sufficient to defray the costs incurred in reviewing, investigating, and administering applications for an amendment to the zoning code pursuant to ' 151.63 shall be \$0
14. The fee for costs incurred in reviewing, investigating and administering applications for a preliminary or final plat pursuant to ' 152.13 shall be \$0
15. The building permit fee shall be \$10.00/\$1000, with an 8-month completion date or a \$750 fine.
16. The Community Center rental fee shall be as follows:
 - \$100 to rent the front
 - \$200 to rent the whole building
 - \$60 to setup the day before or take down the day after
 - \$75 for fundraisers
17. The fee for the City of Waldorf to mow a residents grass pursuant of Ordinance 60 shall be \$75/time.
18. The fee for the City of Waldorf to trim a residents grass pursuant of Ordinance 60 shall be \$50/hour
19. The fee for blowing grass clippings in the street shall be \$25
20. The fee for snow removal shall be \$0
21. The cost for purchasing a tractor bucket load of gravel is \$50/bucket load.
