Committee Head announcements:

- Russ requested event numbers including vendor numbers from the previous event to help us assess what funding will be needed for WFFA 2025.
- Jacob mentioned that we should check in as a PAC to decide if we want to move forward before making any decisions. Russ is worried that we don't have the numbers we need to figure out if we should keep doing the event.
