
Continuation of Contract (Full Terms)

- 1. Customer is responsible for calling "811" or "888-721-7877" (https://sc811.com/homeowners/) at least 3 full days before Phoenix Fencing is scheduled to install your fence. Phoenix Fencing is not responsible for any costs incurred due to breakage of any underground utilities, gas, cable, telephone, water or sprinkler system lines.
- 2. Warping & cracking of wood materials are natural characteristics of the material. The customer is responsible for the initial and regular maintenance of the fence (stain, paint, seal, etc.). Phoenix Fencing provides a one-year warranty on the labor for any issues related to the installation of the fence. This does not include unnatural warping, cracking or destruction of the fence (i.e., acts of God, intentional damage, unintentional damage)
- 3. Customer will pay attorney fees associated with collecting unpaid balance.
- 4. Customer is responsible for specifying post locations. If post needs to be moved after installation, there will be additional charges.
- 5. If property pins are not located, it is recommended to have property surveyed.
- 6. Phoenix Fencing shall not be responsible for delays in deliveries caused by its suppliers, weather conditions, site conditions or any other circumstance beyond its complete control. Installation dates are only estimates and may vary based on these conditions.
- 7. Customer is responsible for all codes and specifications enforced by the City, County & Homeowners Association.
- 8. Phoenix Fencing will remove all left-over materials & scrap wood from the fence.
- 9. Phoenix Fencing is not responsible for damaged to grass & bushes due to installation of the fence.
