Any yet, While the dossier was never verified, the FBI and the Department of Justice used it to get FISA a warrant on Carter Page in October 2016 and again in January, April and June of 2017.

Sen. Josh Hawley (R-Missouri)

JH We now know that in October and then 3 times, October 2016 and three times in 2017, these individuals deliberately, knowingly misled the FISA Court. I mean that's really the nicest way to put it.

Basically, they lied to the FISA Court to get a surveillance warrant of an American citizen.
