Lynch's Deputy Attorney General is Sally Yates. She'd signed off on one of the FISA warrant applications. That warrant, like all the others, misled the court by relying on information from the discredited dossier. Lynch and Yates are atop the Justice Department. Moving down the chain of command we find the DOJ's National Security Division.

John Carlin **is** in charge here. He's an assistant attorney general. His fingerprints would be on any DOJ FISA warrant applications and surveillance ops. What was Carlin up to?

Enter Michael Horowitz, The Justice Department's Inspector General. He wanted to audit Carlin's division. But Deputy Attorney General Sally Yates said no. And explained why in a 58 page memo. Why was Yates blocking an audit?

This FISA Court memo and order provide the clues. It details illegal surveillance of US citizens that occurred while Carlin was in charge.

JD Once this material was submitted To the court,

JD revealing the violations of the law, Carlin resigned.

Carlin reported the Illegal spying to the FISA Court on September 26, 2016 And the next day he announced his resignation, as reported by the Washington Post.

The Scheme Team is long gone from the corner of 9<sup>th</sup> and Pennsylvania but some of them may soon have a date at the Federal Courthouse a few blocks away. This is John Spiropoulos reporting.
