

# DOG MAINTENANCE REGISTRATION

The Grande at Rancocas Creek Condominium Association has a policy to register all dogs residing within the Garden Club. This is necessary because of the excessive amount of dog feces that is littering our neighborhood, making it not only unsightly, but unsanitary. The Association has installed dog waste station, these must be maintained by a contractor at a cost to the community. This cost should be borne by the dog owners. There is also damage to our lawns from dog owners who are allowing their dogs to urinate in the same areas, killing the grass. This also needs to be addressed. It's not fair to make residents, who do not own a dog, pay for these repairs.

There is a small **yearly** fee, \$50.00 for the first dog and \$25.00 for each additional dog that resides within the home. **You are only allowed two pets at the Garden Club.**

You will receive a tag indicating that your dog has been registered and must be displayed on your dog's collar. This is our way of verifying that your dog has been registered.

The Board is not happy to have to impose this type of registration but financially we found it necessary to cover the cost of the additional clean-up of the feces, the repair of the grass and the maintenance of the dog stations. This does not mean that you can leave the dog waste on the ground and we'll dispose of it. You must comply with the Association and Township rule of picking up and disposing of all dog waste. Also please be considerate when allowing your dog to urinate and not let them do it in the same place each time, which kills the grass. Please vary the areas where you allow your dog to go. The designated dog walk areas, which include the berm on Bridgeboro Road and behind the buildings must be utilized.

**You must register your dog(s) by FEBRUARY 15, 2022.** If this is a new pet you will receive a tag indicating that you registered. Failure to register your pet by that date may result in additional fees being assessed to your account. All dogs must also be registered with Delran Township.
