CERTIFICATE OF FORMATION OF THE TIMBERS OF LA VERNIA HOMEOWNERS ASSOCIATION

I, the undersigned, natural person of the age of twenty-one years or more, being a citizen of the State of Texas, acting as the organizer of a corporation under the Texas Business Organizations Code, do hereby adopt the following Certificate of Formation for such Corporation:

ARTICLE I. NAME

The name of the Corporation is The Timbers of La Vernia Homeowners Association, hereinafter referred to as the "Corporation" or the "Association."

ARTICLE II. NONPROFIT

The Corporation is a nonprofit corporation.

ARTICLE III.
PURPOSES

The purposes of the Corporation shall be all lawful purposes of a nonprofit corporation, including but not limited to governing The Timbers Subdivision, Wilson County, Texas, maintaining and administering the common area of The Timbers Subdivision, and the common area of any additional properties which may come within the jurisdiction of the Association, collecting and disbursing the assessments and charges, and similarly dealing with all additional properties which may come within the jurisdiction of the Association by annexation or otherwise, and all other property, real, personal and mixed which the Association may acquire.

ARTICLE IV. MEMBERSHIP

Every record owner, whether one or more persons or entities, of fee simple title in any lot which is subject by covenants of record to assessment by the Association, including contract sellers, shall be a member of the Association. The foregoing is not intended to include persons or entities who hold an interest merely as security for the performance of an obligation. Membership shall be appurtenant to and may not be separated from ownership of any lot which is subject to assessment by the Association.

ARTICLE V. VOTING RIGHTS

The members of the Association shall have voting rights as set forth in the Bylaws of the Association.

ARTICLE VI. BOARD OF DIRECTORS

The affairs of this Association shall be managed by a governing authority, hereby designated as a Board of Directors. There shall be three Directors. Until the first election of the Directors the three Initial Board of Directors, listed in Article X, shall so serve.

ARTICLE VII. DISSOLUTION

The Association may be dissolved with the assent given in writing and signed by not less than two-thirds (2/3) of the Members. Upon dissolution of the Association, other than incident to a merger or consolidation, the assets of the Association shall be distributed in the manner provided by Section 22.304, Texas Business Organizations Code.

ARTICLE VIII. AMENDMENTS

Amendment of this Certificate shall require the assent of three-fourths of all votes of the membership.

ARTICLE IX. REGISTERED AGENT

The street address and mailing address of the initial registered office of the Corporation is 13854 Northwest Military Highway, Suite 102, San Antonio, Texas 78231, and the name of its registered agent at such address is Gerry Yost.

ARTICLE X. INITIAL BOARD OF DIRECTORS
