I emailed Amy saying Sara Emich wouldn't let me take the kids that weekend like we agreed. Sara Emich ended up leaving the kids that weekend leaving them with her dad. Nothing got done about it

Email 12/4/2017 Amy Klugherz to Landon Little

Amy Klugherz sent me Landon Little email saying I recommend you send Sara a text that reads something like. This was because Sara Emich was leaving our 7-year-old son Jacob Little home alone for hours by himself. That's called child endangerment.

Email 12/5/2017 I Landon Little sent a email to Amy Klugherz saying Sara just texted me she filed a harassment order yesterday against me. All because of the text I sent Sara Emich leaving Jacob home alone. Great advice from Jones Law Office.

Email 12/26/2017 I Landon Little sent to Amy Klugherz saying I got severed child support paperwork. But Jones Law Office should have also got that paperwork oh that's right Jones Law Office didn't file the Certificate Of Representation And Parties but according to Jennifer L. Thon Jones went to every court hearing.

Email 1/5/2018 from Landon Little to Amy Klugherz saying I was burnt out and that I miss my kids. I also said the holidays was tough on me without them. Jones Law Office kept letting Sara Emich run the show.

Email 1/30/2018 from Landon Little to Amy Klugherz talking about the emotional abuse I was getting from Sara Emich. Nothing got done about it.

Sara Emich filed for harassment because I sent an email to the directors of Nicollet County and Blue Earth County.

Let it be known that either Nicollet County or Blue Earth County should have started an investigation which never happened.

In my email I asked questions about how Sara Emich received Medical Assistance and how that started child support along with the child endangerment Sara Emich had and was still continuing to do.

Sara Emich's boss told Sara Emich that same day about my email. Sara Emich then filed for harassment.

Once again Sara Emich submitted a false affidavit and lied under oath.

Sara Emich even went as far as to say on her affidavit that I said she had a smelly downstairs if you know what I mean.

Sara Emich also went to her church and lied to the board members.

Sara Emich filed this harassment so I couldn't attend our daughter's graduation/ graduation party for Haily. But also to make sure I couldn't go to church when Haily had her senior church program.

Judge Allison Krehbiel gave Sara Emich her harassment. I was told that it didn't matter about all the lies Sara Emich had said but it was because of the email to Nicollet and Blue Earth County.

Sara Emich filed for harassment because I sent an email to the Nicollet and Blue Earth County directors and both county board members. In this email I ask questions on how Sara Emich was getting away with fraud, child endangerment and more.

Sara Emich submitted false documents and lied under oath in this hearing. I proved that during our hearing but was told by judge Krehbiel none of that mattered the judge was focused on the email I sent.

Once again, I proven in court that Sara Emich committed fraud, child endangerment and much more. And again, nothing happened.

Judge Krehbiel did grant Sara Emich her harassment, but it doesn't stop there.

After the hearing I was told that Sara Emich went and lied to the board members of her church at first Lutheran Church. One of the many places I couldn't go. I was also told that judge Krehbiel also attends that church which I wasn't told in court. Conflict of interest? and add that Sara Emich already knew judge Krehbiel from the past when Sara Emich did drug court when Sara Emich worked for Nicollet County as a case worker.

July 8, 2019, Harassment BY Sara Emich

This Harassment was filed by Sara Emich after I sent an Email to the Nicollet County and Blue Earth County directors and county board members. I had questions that weren't getting answered. I figured someone could answer them.

On May 24, 2019, I sent an email asking how Sara Emich was getting away with medical assistance fraud, child support fraud I even showed Sara Emich's income. I also asked how Sara Emich could be leaving our 7-year-old son home alone for hours. I asked about the social worker who served me child support paperwork and if that's how the county does it that way. I asked how Sara Emich got away with child endangerment when it came to Mike Rydeen doing and saying things to our minor daughter. And how Nicollet County didn't do anything about it. I stated that I talked to Jay Link and Michelle Fischer from Nicollet County, and they did nothing about it. I talked about how Sara Emich is backed by Nicollet County. I talked about the system being broken and even offered to sit down and hear what they had to say. No one even responded

Harassment July 8, 2019, Filed By Sara Emich

Once again Sara Emich filed false documents in the harassment. Judge Krehbiel you told me during that hearing that those documents didn't matter that it was the email I sent to the county was the main reason for the harassment. Ok so the fact that nobody responded back from the county tells me this. Sara Emich was protected by both Nicollet and Blue Earth County. I mean Sara Emich kept her job as a Mental Health Supervisor with Blue Earth County even after proving everything Sara Emich has done.

The one thing I'm most disappointed in that hearing was you Judge Krehbiel agreeing with Sara Emich on the October police report from 2005 that Sara Emich has assaulted me, and Sara Emich said it was fake. That one hurt but I get it Sara Emich had to keep that off the record or else she would lose her job.

After Sara Emich won her harassment, I had a few people tell me some facts about Sara Emich and First Lutheran Church where Sara Emich went to church. I was told by a board member that Sara Emich had gone and talked to the board members of the church and said that I abused Sara Emich for years. Which was a lie. I also was told that you Judge Krehbiel was a church member at that church. Which I didn't know about. Once again Sara Emich used whoever to get what she wants. Sara Emich now lying to board members of a church.



Good morning,

My name is Landon Little, I am from St. Peter, Minnesota.

I am sending you this email to inform you of what is going on with Sara Emich, Blue Earth County and Nicollet County.

Sara Emich is the Blue Earth County Mental Health Center Supervisor.

Here are the facts:

10/13/2017 I received a letter from Nicollet County asking for my past paystubs for reimbursement for the cost of the insurance for all of the household members enrolled in Medical Assistance. It says Medical Insurance was approved. The letter was sent by Lisa Radloff. I never signed up for this. Sara Emich filed for Medical Assistance knowing it would start Child Support.

11/16/2017 County of Nicollet and Sara Emich Petitioner (S) vs Landon James Little Respondent (S)

Attorney for the County IV-D Agency

11/16/2017 Signed by Jennifer L Cooklock, Assistant County Attorney

In the child support packet it shows Sara Emich's monthly income received is \$6192.00.

\$35.75 per hour based on 40 hours per week

$\$35.75 / \text{hour} \times 40 \text{ hours/week} = \$1430 \times 4.33 \text{ weeks/month} = \6191.90

That's over \$74,000 a year. I looked up the Income and Assets Guidelines for Medical Insurance and I still don't understand how she received assistance. The mediator we had in May and my lawyer also did not understand this.

12/4/2017-On 12/4/2017 I met with my lawyer that morning to talk about Sara Emich leaving our youngest son Jacob Little (who was 7 year's old at the time) home alone after school or school during closings. That morning I sent a text to Sara that my lawyer had written saying I wanted Jacob every day after school. A few hours later, Sara Emich filed a Harassment Restraining Order against me. We went to court and County Judicial Judge Allison Krehbiel threw out the case.

12/23/2017- I was served Child Support papers on 12/23/2017 (notice the date?) I was sent a text from a Nicollet County Worker telling me I was being served papers and asked if I could drive over to Mankato to meet and pick them up. I live in St Peter and was out of town at the time and told her I could meet her in St Peter. She delivered the paperwork at my apartment that night. Her first name was Lori and her # 5073407870. Is this how the County conducts their business?

Looking through some of the child support documents, I see a few thing's that are wrong:

#7 Landon James Little and Sara Marie Emich signed a Recognition of Parentage for the following joint child(ren):

Owen James Little

Haily Marie Little



Jacob James Little

But yet, I am told after leaving Sara in August that I had no custody of any of the kids. Yes, we were never married but together for more than 19.5 years. This needs to be fixed. I fought like hell to get to spend any time with my kids because Sara is a controlling person. But that's a different email and for the court.

#11 Sara Marie Emich's total monthly household expenses are \$ 3,800 for a household of 1 adult and 3 child(ren).

Now this is interesting to me. So, I went to Wells Fargo and pulled our joint checking account info and once again Sara lied.

#15 Sara Marie Emich receives Medical Assistance through MNSure

I work for the State Of Minnesota at the Minnesota State Hospital and have been covering all 3 kids since 2013. But yet, I was told my insurance wasn't good enough from Sara Emich and Lisa Radloff.

#21 Landon James Little basic support obligation according to the Minnesota child support guidelines is \$823.00 a month.

Sara made a lot more than me, but yet I'm paying her half my paychecks. Sounds fair right? Or is our system failing again and sinking a father who has been fighting for custody of his kids?

#26 Landon James Little health care coverage is appropriate, pursuant to the Minnesota statutes section 518A.41.

I was told it wasn't and that's why Sara Emich needed Medical Assistance

#31 From 09/01/2017 to 12/31/2017 Landon James Little has not contributed to the support of the joint child(ren)

The text from Sara thanking me for buying the kids school supplies and taking the kids shopping for school clothes isn't contributing? They also spent almost every weekend with me starting September 1 2017 so Sara could go out. I have kept all my receipts since I have moved out and can show that once again Sara Emich has lied.

5/9/2018 I sent an email to the Nicollet County worker Angela Obermiller asking for help saying I didn't know who to trust at Nicollet County. Sara's boyfriend, Mike Rydeen, was and is saying inappropriate thing's to our daughter Haily who was 16 year's old.

5/14/2018 I got a letter from Nicollet County saying based on the criteria, your report regarding Haily Little has been screened out.

In the audio from Haily talking about Mike Rydeen, Haily said she had told Sara that Haily wanted him to stop and he hasn't. I'm sorry but that's child endangerment on Sara Emich's part. What does Sara Emich do for a job again? Also, Haily now drinks with Mike and Sara and she's 17 years old. And yes, I can back this up.

6/1/2018 Sara called me at 130 a.m. after we just had mediation on 5/31/2018. She agreed to give me 50/50 and to drop child support. She said she didn't want to sink me anymore. Sara typed up an email to

both our lawyers saying she was going to give me 50/50 and drop child support. But it was all a lie to buy some time to collect more child support. Sara and I were at Luther College in July of 2018 with Owen and Sara told me she needed the child support money so her and Mike could go on vacation.

7/13/2018-Our oldest child turned 18 year's old on 7/13/2018. Sara refused to go to court that week to drop Owen from child support. Owen was dropped from child support in August. I asked Nicollet County if I was going to get that money back and they just laughed and did not attempt to help me.

I strongly believe this system is broken.

I talked to Jay Link about a year ago about the Medical Assistance and nothing ever got done. Also, County attorney Michelle Fischer knows about Sara Emich receiving Medical Assistance.

As I have seen firsthand, I understand nobody will do anything from the County and hold people accountable for their actions. That's where I want to step in and handle this matter. What you need to know is everything I have against Sara Emich and the County is backed up. I do strongly believe Sara Emich committed two counts of fraud for Medical Assistance and child support. Also, child endangerment and trying to sink the father of our three kids. I was also physically abused for 17 years from Sara Emich which is backed up with police reports. (But I will save that for court).

The system we have in place favors people like Sara Emich and that needs to stop. I am telling my story to everyone to change this broken system. Fathers should not be treated like this by mothers like Sara Emich and the county.

I am open to sit down with anyone who has more questions.

Sara Emich Trying To Get Me To Break The Harassment

Sara Emich tried multiple times to get me to break the harassment.

One thing I never understood. So I can't be within several feet of your house but you can come into mine.

No doubt Sara Emich wanted me behind bars and would say and use anyone to do it. Sara Emich tried multiple times to use our youngest son but it never worked.

At this time Sara Emich was working for Blue Earth County. When you receive a call from a county landline it says Restricted. Notice how many times Sara Emich tried calling me while the harassment was in place.

I even have a video/ audio of Sara Emich using our youngest son to call me just so she can talk to me. In that audio I said we shouldn't be talking to each other. Sara Emich says well that's your fault.

Once again Sara Emich does and uses whomever she wants and that's including our kids.

12/23/2019 Sara Emich getting Jacob

On Monday Dec 23 2019 I came to my apartment around 345pm I was stopped by [redacted] who is the apartment Supervisor and she told me Sara Emich was standing in the lobby dialing random numbers to try to get ahold of me to get Jacob. [redacted] said it was about 8am or a little bit before 8am when [redacted] opened the door to see if Sara needed help. [redacted] asked Sara if she wanted to come in and get Jacob and Sara told [redacted] she couldn't then seconds later walked in the building to go to my apartment. [redacted] said Sara walked in and asked what apartment was mine then ended up walking out of the building without Jacob. My guess is Sara saw the camera and walked out. At 814am 12/23/2019 Sara sent me a text saying Jacobs gizmo is dead. I went to work at 7am and I work at MSOP and can't have my phone on me. When I went to break I checked my phone and saw Sara emailed me. I called Jacob at 954am and he picked up. I asked him if Sara got him and he said yes and they were heading to the eye doctor. I asked Jacob how Sara got him to come out and Jacob replied mom called me on my gizmo. What was the purpose of this from Sara?

SYNOPSIS:

Sara Emich Breaking Her Harassment

Since the beginning of Sara Emich's harassment Sara has tried to make me break the harassment. And Sara Emich used Jacob Little each time to do so. Jacob Little and I counted at least over ten times Sara Emich had tried. Here is just a few examples

June 7, 2019, 2:17pm Jacob Little called and wanted me to drop off his golf clubs at Sara Emich's house. Jacob said Sara Emich said to tell me to drop it them off at her house.

June 16, 2019, 2:59pm Jacob wanted me to pick him up at Sara Emich's house and I said no. Later when Jacob was with me, he said Sara Emich was sitting right next to him telling him to say that.

June 20, 2019, 4:10pm I went to the police department asking how to get Jacob Little from Sara Emich's. I told Jacob I would pick him up at North Elementary and Jacob said that Sara Emich said I had to pick him up at her house. My NURSE girlfriend at the time went and picked Jacob up. There is video and audio of Jacob Little talking about this situation.

June 28, 2021, 5:44pm Audio and video of Sara Emich using Jacob Little to call me.

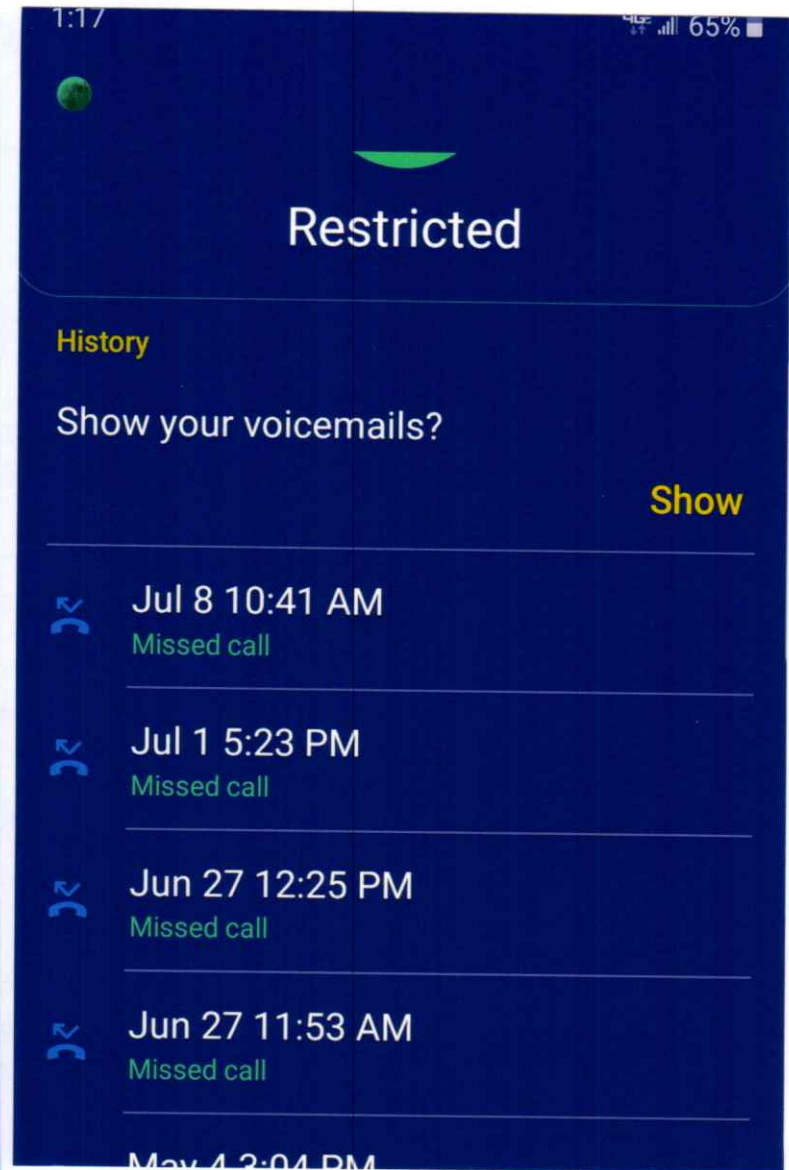
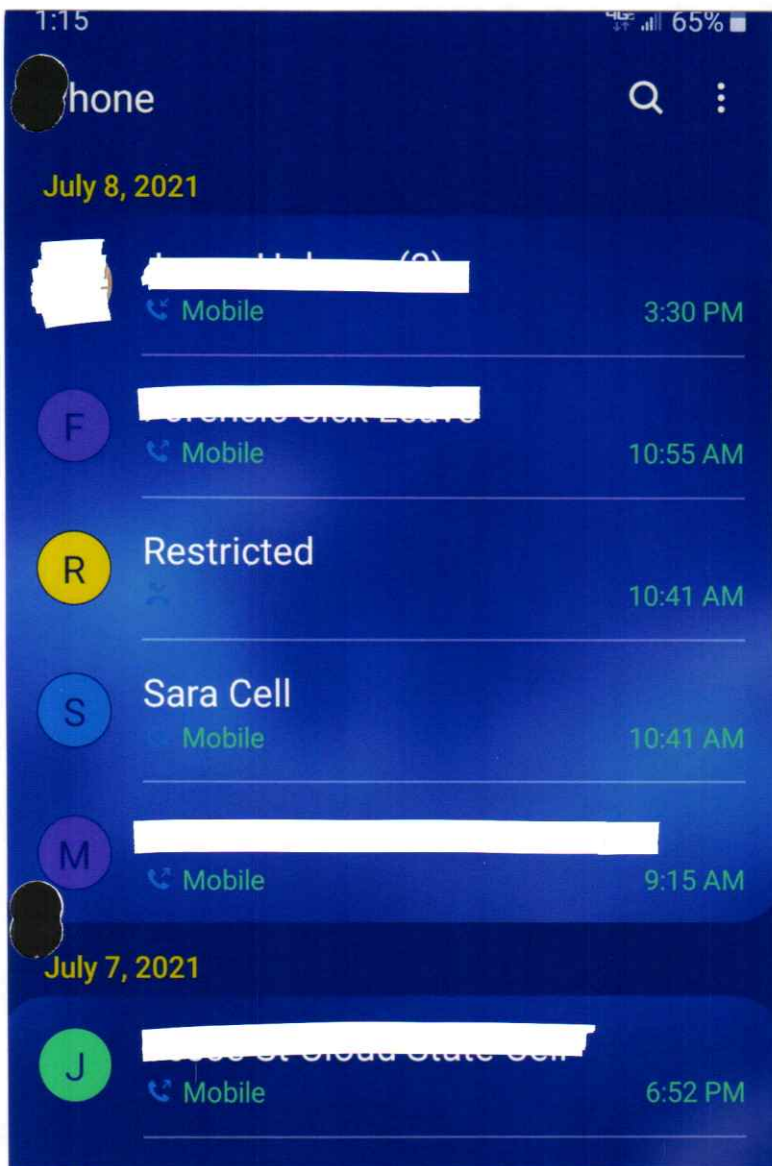

Here is some more of Sara Emich breaking her own harassment. My phone call log showing Sara Emich calling me on July 8, 2021.

Notice the restricted call right before Sara Emich tried calling me from her cell. When Sara Emich and I was together when Sara would call me from her office at Blue Earth County it would pop up as restricted. Notice the call log? July 8, July 1, June 27, June 27 again remember Sara Emich was trying to get ahold of me because Sara Emich wasn't taking Jacob on vacation anymore? Twice that day. So many more times Sara Emich tried to call, and I didn't answer.

It makes you wonder why you would file for harassment then try to make me break it and why would you continue to try to call me. Never mind I forgot Sara Emich is allowed to do whatever Sara Emich wants to.

The above-entitled matter came on for hearing on October 9, 2023 before the undersigned Judge of District Court via Zoom. Petitioner appeared in person and through counsel, Kezia Smith. Respondent appeared in person and was pro se.

The matter came on for hearing upon Petitioner's request for a harassment restraining order ("HRO") against Respondent.¹

The following witnesses testified: Petitioner and Respondent.

Petitioner had previously filed exhibits on MNDES. Those exhibits were admitted during the hearing as set forth in the minutes of the Court Administrator.

Based upon the evidence received at the hearing and the contents of the file, the Court makes the following:

¹ The Court had previously on August 16, 2023 issued an Ex Parte HRO restraining Respondent from contact with Petitioner. Petitioner had in her petition requested an order covering both her and the parties' minor child, Jacob Little. The Court issued the Ex Parte HRO with respect to Petitioner only, due to the lack of allegations about conduct directed toward Jacob. The Court subsequently extended the Ex Parte HRO until the date of the October 9th hearing.

FINDINGS OF FACT

1. Petitioner is Sara Emich. Respondent is Landon Little. Petitioner and Respondent were in a longer-term relationship in the past. They had three children together, one of whom is still a minor. That child is Jacob James Little, born January 2, 2010 and almost 14 years old.
2. On May 10, 2023, the parties were emailing about Jacob playing baseball and about a vacation that Petitioner wished to take with Jacob. Respondent apparently became irritated at some point during the email exchange and wrote, "You can't even take care or protect Jacob in the small town of St. Peter no way you can in Columbia. Plus I don't think Nicollet County or the Fifth Judicial District can protect you in Columbia just saying". *Ex 2*. Later in the email Respondent wrote, "Anyone involved with you will be seeing lawsuits from me". *Id*.
3. The May 10th conversation involved a parenting time dispute to which Respondent reacted poorly and strangely. However, he did not threaten
→ Petitioner in that conversation. Respondent referred to bringing future
litigation against other parties.
- 4. Petitioner testified to an incident on July 7, 2023 when Respondent picked up Jacob for parenting time. According to Petitioner, Respondent "aggressively drove through the neighborhood at a high speed until he stopped at the end of Petitioner's driveway. Jacob got into the vehicle with Respondent. Petitioner testified that Respondent then reached behind Jacob's back, formed his hand

Sara was at work. According to Jacob

→ into the shape of a gun and made a shooting motion toward Petitioner and her ←
significant other, Mike Rydeen. Respondent then drove away with Jacob.

5. Respondent testified that he picked up Jacob from the intersection of Bonnie Lane and Traverse on July 7th, which is several houses away from Petitioner's residence.² Respondent testified that he picks up Jacob at the intersection "90% of the time" so as to avoid being accused of things by Petitioner.

According to Respondent, he arrived at 10:30 a.m. on July 7th, which was later than originally planned because he wished to allow Jacob to sleep longer that day. Respondent asked Jacob if Petitioner were upset that he had come late.

According to Respondent, Jacob stated that Petitioner was not home, but at work. July 7, 2023 was a Friday, so it would be logical for Petitioner to be at work. Respondent had taken the day off work to pick up Jacob to go to a baseball tournament in Sioux Falls.

6. The Court finds Respondent's testimony regarding the allegedly July 7th incident to be credible. Given the parties' extensive history of difficulties and allegations, it would make sense for Respondent to avoid picking up Jacob directly in front of Petitioner's house. July 7th was a Friday, and it would be logical for Petitioner – and Mike Rydeen – to be at work instead of at Petitioner's house. Respondent had specifically taken off that day to take

² The map of St. Peter indicates that ~~Bonnie Lane~~ actually intersects Edgerton Street, which in turn intersects Traverse Street. The Court may take judicial notice of a fact that is not subject to reasonable dispute in that it is either: (1) generally known within the territorial jurisdiction of the trial court, or (2) capable of accurate and ready determination by resort to sources whose accuracy cannot reasonably be questioned. *Minn.R.Evid. 201(b)*.

symptoms due to what Petitioner has done to him. *Ex. 3.* Respondent claimed financial loss as a result of his health troubles. Petitioner testified that Exhibit 3 was one of the pages that Respondent attached to Exhibit 1.

12. Exhibit 4 is a document entitled "Closing Thoughts." In that document, Respondent questioned what income Petitioner claimed when Owen, the parties' oldest child, applied to college in 2017. Respondent opined that the assets of Petitioner and Mike Rydeen should be frozen. Respondent stated that "each one of you" had helped Petitioner to "bury [him] and kill [him] off as a father." *Ex. 4.* Petitioner testified that Exhibit 4 was one of the pages that Respondent attached to Exhibit 1.

13. Exhibit 5 is a letter from Respondent to Petitioner. In that letter, Respondent asserted that Petitioner had on September 24, 1999 drugged and raped Respondent and thereby became pregnant with the parties' first child, Owen. *Ex. 5.* Respondent further accused Petitioner of having an abortion in October 2023 with "someone else's baby." *Id.* Respondent referred to Petitioner on July 10, 2005 going to the apartment of a co-worker next to the Flame Bar in St. Peter to have sex. *Id.* Respondent referred to Petitioner "staying out late" with a Mankato police detective in March 2017. Respondent claimed that Petitioner punched him in the face in October 2005 but that nothing was done about it for fear of Petitioner losing her employment. *Id.* Respondent also claimed that the parties' child was conceived as a result of Petitioner drugging and raping Respondent on September 24, 1999. Petitioner testified that Exhibit 5 was one of the pages that Respondent attached to Exhibit 1.

subd. 2. A petition for relief must allege facts sufficient to show that the respondent engaged in harassment. *Minn. Stat. §609.748, subd. 3.*

“Harassment” includes a single incident of physical or sexual assault or repeated incidents of intrusive or unwanted acts, words, or gestures that have a substantial adverse effect or are intended to have a substantial adverse effect on the safety, security, or privacy of another, regardless of the relationship between the actor and the intended target. *Minn. Stat. §609.748, subd. 1(a).*

2. The statute requires proof of objectively unreasonable conduct or intent on the part of the harasser. *Peterson v. Johnson*, 755 N.W.2d 758, 764 (Minn. App. 2008)(citing *Dunham v. Roer*, 708 N.W.2d 552, 567 (Minn. App. 2006)). The statute also requires proof of an objectively reasonable belief on the part of the person subject to harassing conduct. *Id.* (citing *Dunham* and also *Kush v. Mathison*, 683 N.W.2d 841, 845 (Minn. App. 2004)).
3. The burden of proof in this matter is that of a preponderance of evidence. A fair preponderance of the evidence means that it must be established by a greater weight of the evidence, that it is more likely that the claim is true than that it is not true. *State v. Maley*, 714 N.W.2d 708, 711 (Minn. App. 2006).



4. Petitioner is not entitled to an HRO.



Based upon the foregoing, the Court makes the following:

ORDER

1. Respondent shall not harass Petitioner.
2. Respondent shall have no direct or indirect contact with Petitioner, including any visits, text messages, or phone calls, or any contact via electronic means

With that being said a change is needed. Also, if anyone should file for harassment it should be me.

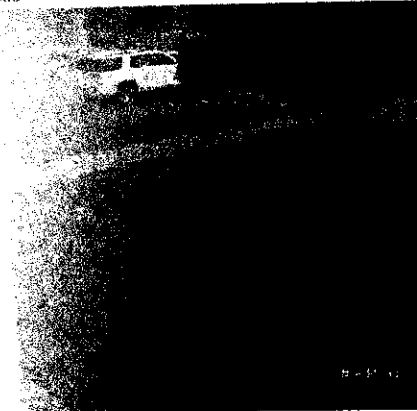
