### **Medical Assistance Fraud**

Here is what we know. In August 2017 Sara Emich applied for medical assistance knowing that it would start a child support case against me.

Documents from Nicollet County Human Services case number 1054374 shows Sara Emich's Net income was \$5677.00 a month. Those dates are 06/01/2017 to 11/30/2017. Total six-month income \$34,062 and a six-month income standard of \$34,395.

If I remember right Sara Emich gets 1 of 2 raises in July and the other coming in January. Did Sara Emich get a raise in July 2017? Also, back in 2014/2015 Sara Emich while working at Blue Earth County was also working at Sibley County. I remember Sara's checks from Sibley County being over \$2,000 with no taxes being taken out. Did Sara Emich have other income coming in she wasn't providing when getting Medical Assistance?

Case Number 52-FA-17-801 child support guidelines worksheet page 1 shows Sara Emich's monthly income received was \$6,192.00. Date from 09/01/2017 to 12/31/2017. I find it ingesting that this document doesn't show July. On the last document it went back to June 2017. But this time they didn't. Is it because Sara Emich got a raise in July 2017?

Here is where things get interesting. Finding of the facts for child support dated and signed on 1/25/2018 # 18 Sara Emich receives Medical Assistance through MnSure. # 20 Sara Emich hourly wage is \$35.75 per hour.

So, Nicollet County along with Sara Emich is saying between 6/2017 to 1/25/2018 Sara Emich never got a raise. But hold on. In the Agreement Between County of Blue Earth and The American Federation Of State, County, And Municipal Employees Minnesota Council NO. 65 it says in

Article 22 under wages that a 2.5% wage increase shall be applied to wage schedule effective Jan 1.

Let's talk about that raise Sara Emich got on Jan 1, 2018. Financial statement on page 2 #14 Sara Emich hourly wage was now \$36.47. A 72 cent raise in which a statement from Sara Emich in court and on documents Sara Emich said she made to much for Medical Assistance. 72 cents interesting.

So, Sara Emich got her raise Jan 1, 2018, but medical assistance didn't get canceled until March 2018. You have 10 days to notify the county in change of wages. I'm going to go ahead and say that didn't happen.

Alright let's get to some other points. In a court document that Sara Emich summitted Sara says her modified gross annual income was \$67,271.78 which was 277.8% of the poverty guidelines, which was within a 3% grace period.

Here is the best part Sara Emich says the income guidelines for a family of 4 is annually \$69,025 for 7/1/2018 to 6/30/2019. My exhibit 36 shows the chart for medical assistance guidelines from 7/1/2017 to 6/30/2018. A family of 4 monthly is \$4,101 and annually \$49,212. 200% FPG.

I'm confused on how Sara Emich got medical assistance. Until it all started to come together and make sense. Fraud

See Sara Emich knew the moment she signed up for medical assistance it would start a case for child support. Sara Emich for a few years was a social worker at Nicollet County before becoming the Mental Health supervisor at Blue Earth County. Sara Emich has her friends at Nicollet County, and they would do anything to help and protect her. Oh, wait it gets better.

We now can add corruption along with fraud.

Let's start with the letter from October 13, 2017, from Lisa Radloff from Nicollet County saying that my request for cost effective health insurance reimbursement was approved for medical insurance for my kids. I never signed a document. I worked for the state and had the kids under my insurance. Who signed my name? Plus, I was going to be paying child support so that can't work. Whenever Sara Emich would use the medical assistance over my insurance for the kids guess who paid for it. Yep, I did. So, I was paying Sara Emich \$823 a month for child support, paying for the kids' insurance under my work and paying the county back for Sara Emich using medical assistance. Seems about right.

On May 24, 2019, I sent an email to the directors and board members of Nicollet County and Blue Earth County. You want to talk about corruption and fraud at its finest you must read this email. Not a single person said or did anything about any of this. It's sad because kids are involved. But I get it the county must protect Sara Emich they are already into deep at this point.

It's mind blowing to see how many people that protected Sara Emich.

After the harassment hearing I knew just how high corruption and fraud had hit.

Judge Krehbiel from the fifth district court in Nicollet County. I kid you not the judge has done everything to protect Sara Emich. I haven't even gotten to the court hearings for child custody which shows judge Krehbiel has her hand big time with corruption and fraud.

As you can see in the paperwork at the end of the binder just how much corruption and fraud I have had to deal with. And that's not even all of it.

As a father of three kids all with Sara Emich it hasn't been easy. I dealt with over 20 years of Sara Emich controlling and 17 years of being physically abused by Sara Emich. I watched as Sara Emich along with Nicollet County try to financially sink me and kill me off as a father. Sara Emich made double of what I made for income, but I paid her \$823 in child support. Sara Emich did whatever she could to make sure I didn't get my parent rights. Sara Emich cares about three things herself, control and money. Sara Emich will use whoever to get what she wants.

I want justice not just for me but for my kids also. They see what Sara Emich has done and thinks it's ok because she gets away with it. I wasn't raised that way. How can someone like Sara Emich control so many people? To say I have more than enough evidence to show the corruption and fraud that goes on in Nicollet County and Blue Earth County is a under statement. I can't go to the state because they will do nothing.

I'm hoping you are willing to sit down and talk to me about everything.



### Medical Assistance Documentation

The Medical Assistance case was MA for the kids only, not myself. 10/8/18, I called Tami Simonson, financial worker and received the following information. The kids MA opened retro to June 2017. My modified gross annual income was 67,271.78, which was 277.8% of the poverty guideline, which was within the 3% grace period, therefore the kids qualified for MA. In Jan 2018 I received a cost of living raise and per MA program guidelines, I reported the raise to the financial worker. My modified gross annual income was \$69,788.34, which was 283%, which was over the limit. The MA case was closed in March 2018 as I was over income. Taking it from another view, the income guidelines for a family of 4 is annually \$69,025 for 7/1/18-6/30/19, so you can see the MA income guidelines are high for a public assistance program. There is a release on file and Landon can and has called the financial worker. This has been an ongoing issue of Landon's. He also says he reported fraud to Michelle Zender Fisher and the State Attorney's Office. That's fine with me. I've cooperated with all program rules and accurately and honestly reported income. I've not been contacted for any fraud investigation.

### **Medical Assistance Fraud**

In Sara Emich's court document for harassment Sara says the kid's medical assistance was opened retro to June 2017. Did Sara Emich get a raise in July 2017? Like a step raise for the county not the cost of living raise Sara Emich got on January 1, 2018.

Sara Emich states in the court document for the harassment case on July 8, 2019, that Sara Emich reported that she in January 2018 she received a cost of living raise and per MA program guidelines Sara reported her raise. Sara Emich states her modified gross annual income was \$69,788.34 which was 283%, which was over the limit.

Ok so now I have a few questions. First off Sara Emich not only got a cost of living raise but also got \$823 for child support from me a month which also needed to be added for income to medical assistance. Sara Emich received medical assistance until March of 2018. HOW? You have ten days to let the county know about any change in wages or income.

### HERE IS THE BEST PART

Sara Emich's raise in January for cost of living was 72 cents. 72 cents put Sara Emich over the limit for medical assistance.

\$36.74x40=\$1458.80x4.33=\$6316x12 months= \$75,792 a year. And let's not forget another \$823 a month for child support.

On May 31 2018 Sara Emich told the mediator at Kennedy and Kennedy law firm that Medical Assistance got dropped in March of 2018 because Sara Emich got a raise. Sara Emich got a 72 cent raise. I'm guessing she got that on Jan 1 2018 when the county gets there raise. One other thing to note is Sara Emich started to get child support from me Landon Little Jan 1 2018 which was \$823 a month. Nicollet County told me Sara Emich would have had to claim that for Medical Assistance but did she?

My name is Landon Little, I am from St. Peter, Minnesota.

I am sending you this email to inform you of what is going on with Sara Emich, Blue Earth County and Nicollet County.

Sara Emich is the Blue Earth County Mental Heath Center Supervisor.

Here are the facts:

10/13/2017 I received a letter from Nicollet County asking for my past paystubs for reimbursement for the cost of the insurance for all of the household members enrolled in Medical Assistance. It says Medical Insurance was approved. The letter was sent by Lisa Radloff. I never signed up for this. Sara Emich filed for Medical Assistance knowing it would start Child Support.

11/16/2017 County of Nicollet and Sara Emich Petitioner (S) vs Landon James Little Respondent (S)

In the child support packet it shows Sara Emich's monthly income received is \$6192.00.

\$35.75 per hour based on 40 hours per week

\$35.75 / hour x 40 hours/ week =\$1430 x 4.33 weeks/ month =\$6191.90

That's over \$74,000 a year. I looked up the Income and Assets Guidelines for Medical Insurance and I still don't understand how she received assistance. The mediator we had in May and my lawyer also did not understand this.

12/4/2017-On 12/4/2017 I met with my lawyer that morning to talk about Sara Emich leaving our youngest son Jacob Little (who was 7 year's old at the time) home alone after school or school during closings. That morning I sent a text to Sara that my lawyer had written saying I wanted Jacob every day after school. A few hours later, Sara Emich filed a Harassment Restraining Order against me. We went to court and County Judicial Judge Allison Krehbiel threw out the case.

12/23/2017- I was served Child Support papers on 12/23/2017 (notice the date?) I was sent a text from a Nicollet County Worker telling me I was being served papers and asked if I could drive over to Mankato to meet and pick them up. I live in St Peter and was out of town at the time and told her I could meet her in St Peter. She delivered the paperwork at my apartment that night. Her first name was Lori and her # 5073407870. Is this how the County conducts their business?

Looking through some of the child support documents, I see a few thing's that are wrong:

#7 Landon James Little and Sara Marie Emich signed a Recognition of Parentage for the following joint child(ren):

But yet, I am told after leaving Sara in August that I had no custody of any of the kids. Yes, we were never married but together for more than 19.5 years. This needs to be fixed. I fought like hell to get to spend any time with my kids because Sara is a controlling person. But that's a different email and for the court.

#11 Sara Marie Emich's total monthly household expenses are \$ 3,800 for a household of 1 adult and 3 child(ren).

Now this is interesting to me. So, I went to Wells Fargo and pulled our joint checking account info and once again Sara lied.

#15 Sara Marie Emich receives Medical Assistance through MNSure

I work for the State Of Minnesota at the Minnesota State Hospital and have been covering all 3 kids since 2013. But yet, I was told my insurance wasn't good enough from Sara Emich and Lisa Radloff.

#21 Landon James Little basic support obligation according to the Minnesota child support guidelines is \$823.00 a month.

Sara made a lot more than me, but yet I'm paying her half my paychecks. Sounds fair right? Or is our system failing again and sinking a father who has been fighting for custody of his kids?

#26 Landon James Little health care coverage is appropriate, pursuant to the Minnesota statutes section 518A.41.

I was told it wasn't and that's why Sara Emich needed Medical Assistance

#31 From 09/01/2017 to 12/31/2017 Landon James Little has not contributed to the support of the joint child(ren)

The text from Sara thanking me for buying the kids school supplies and taking the kids shopping for school clothes isn't contributing? They also spent almost every weekend with me starting September 1 2017 so Sara could go out. I have kept all my receipts since I have moved out and can show that once again Sara Emich has lied.

5/9/2018 I sent an email to the Nicollet County worker Angela Obermiller asking for help saying I didn't know who to trust at Nicollet County. Sara's boyfriend, Mike Rydeen, was and is saying inappropriate thing's to our daughter Haily who was 16 year's old.

5/14/2018 I got a letter from Nicollet County saying based on the criteria, your report regarding Haily Little has been screened out.

In the audio from Haily talking about Mike Rydeen, Haily said she had told Sara that Haily wanted him to stop and he hasn't. I'm sorry but that's child endangerment on Sara Emich's part. What does Sara Emich do for a job again? Also, Haily now drinks with Mike and Sara and she's 17 years old. And yes, I can back this up.

6/1/2018 Sara called me at 130 a.m. after we just had mediation on 5/31/2018. She agreed to give me 50/50 and to drop child support. She said she didn't want to sink me anymore. Sara typed up an email to



both our lawyers saying she was going to give me 50/50 and drop child support. But it was all a lie to buy some time to collect more child support. Sara and I were at Luther College in July of 2018 with Owen when and Sara told me she needed the child support money so her and Mike could go on vacation.

7/13/2018-Our oldest child turned 18 year's old on 7/13/2018. Sara refused to go to court that week to drop Owen from child support. Owen was dropped from child support in August. I asked Nicollet County if I was going to get that money back and they just laughed and did not attempt to help me.

I strongly believe this system is broken.

I talked to Jay Link about a year ago about the Medical Assistance and nothing ever got done. Also, County attorney Michelle Fischer knows about Sara Emich receiving Medical Assistance.

As I have seen firsthand, I understand nobody will do anything from the County and hold people accountable for their actions. That's where I want to step in and handle this matter. What you need to know is everything I have against Sara Emich and the County is backed up. I do strongly believe Sara Emich committed two counts of fraud for Medical Assistance and child support. Also, child endangerment and trying to sink the father of our three kids. I was also physically abused for 17 years from Sara Emich which is backed up with police reports. (But I will save that for court).

The system we have in place favors people like Sara Emich and that needs to stop. I am telling my story to everyone to change this broken system. Fathers should not be treated like this by mothers like Sara Emich and the county.
