The AmeriCorps program at NOS offers opportunities for partner non-profit and government agencies to host a national service member to help advance their mission. Some of the national service members from this grant also serve with Nevada Outdoor School to assist with the planning, implementation and devliery of our outdoor education programs.

4b (Code:) (Expenses \$ 178,904. including grants of \$) (Revenue \$) Department of Interior, Bureau of Land Management (BLM) Grants: Nevada Outdoor School (NOS) has maintained an assistance agreement with the BLM since our organization was founded in 2002. Currently we have a statewide assistance agreement that helps support our outdoor education, community outdoor events and off highway vehicles safety eduction throughout the state. We also have an assistance agreement with the Elko District to support their California Trail education programs at the California Trail Interpretive Center and with the Winnemucca District to support various community hikes, clean up projects and youth outdoor education initiatives.
