

# Privacy Policy

This Privacy Policy applies to Kilkenny Chiropractic, LLC and [www.kilkennychiropractic.com](http://www.kilkennychiropractic.com). It governs data collection and usage. For the purpose of this Privacy Policy, unless noted otherwise, all references to Kilkenny Chiropractic, LLC include [www.kilkennychiropractic.com](http://www.kilkennychiropractic.com). Kilkenny Chiropractic, LLC's website is used to provide news, information about chiropractic, and as an appointment platform. By using our website, you consent to the following data practices as described below.

**Collection of your personal information** – To better provide you with our services and products, Kilkenny Chiropractic, LLC may collect personally identifiable information, such as your:

- ◆ First and last name
- ◆ Date of birth/age
- ◆ Gender
- ◆ Mailing address
- ◆ Email address
- ◆ Phone numbers
- ◆ Employer/job title
- ◆ Insurance information
- ◆ Emergency contact information
- ◆ Primary care physician contact information
- ◆ Personal and family health history

If you receive any service or product from Kilkenny Chiropractic, LLC, payment information is used to complete the purchase transaction but none of it will be stored for future use.

We do not collect any personal information about you unless you voluntarily provide it to us. You may be required to provide certain personal information to us when you choose to receive services and/or products.

Kilkenny Chiropractic, LLC may use your information to communicate with you in relation to the services and/or products you receive. Gathering more information from you in the future is a possibility.

**Use of your personal information** - Kilkenny Chiropractic, LLC collects and uses your personal information in the following ways:

- ◆ To provide you with notices about your account such as appointment reminders, fees, etc.

Kilkenny Chiropractic, LLC may disclose your personal information, without notice, if required by law or in the good faith belief that such action is necessary to: conform to the edicts of the law or comply with legal process served upon Kilkenny Chiropractic, LLC, protect and defend the rights or property of Kilkenny Chiropractic, LLC, and/or act under exigent circumstances to protect the personal safety of Kilkenny Chiropractic, LLC or the public.

**Automatically collected information** - Kilkenny Chiropractic, LLC may automatically collect information about your computer and software. This information can include your IP address, browser type, domain name, access times, and referring website addresses. This information is used for the operation of the service, to maintain the quality of our services, and to provide general statistics regarding the use of our website.

**Security of your personal information** - Kilkenny Chiropractic, LLC secures your personal information from unauthorized access, use, and/or disclosure. Kilkenny Chiropractic, LLC uses SSL Protocol. We strive to take appropriate security measures

to protect you against access to your personal information. Unfortunately, no Internet data transmission or any wireless network can be 100% guaranteed secure. While we strive to protect your personal information, you acknowledge that there are security and privacy limitations inherent to using the Internet that are beyond our control and the security, integrity, and privacy of any and all information and data exchanged between you and us through this site cannot be guaranteed.

**Use of “cookies”** - Kilkenny Chiropractic, LLC’s website may use “cookies” to help personalize your online experience. You will see a text notification regarding this when you go to our website. A “cookie” is a text file that is placed on your hard disk by a web page server. “Cookies” cannot be used to run programs or deliver viruses to your computer. “Cookies” are uniquely assigned to you and can only be read by the web server in the domain that issued the “cookie”. Upon verifiable request from you, your website account can be deleted so that you will no longer receive any text or email appointment reminders or any other marketing communications including birthday emails, social posts, etc.

**Children under thirteen** - Kilkenny Chiropractic, LLC does not knowingly collect personal information from children under the age of 13. If you are under the age of 13, you **must** get permission from one of your parents or guardians to use our website.
