

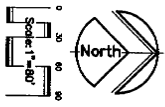
Location Map

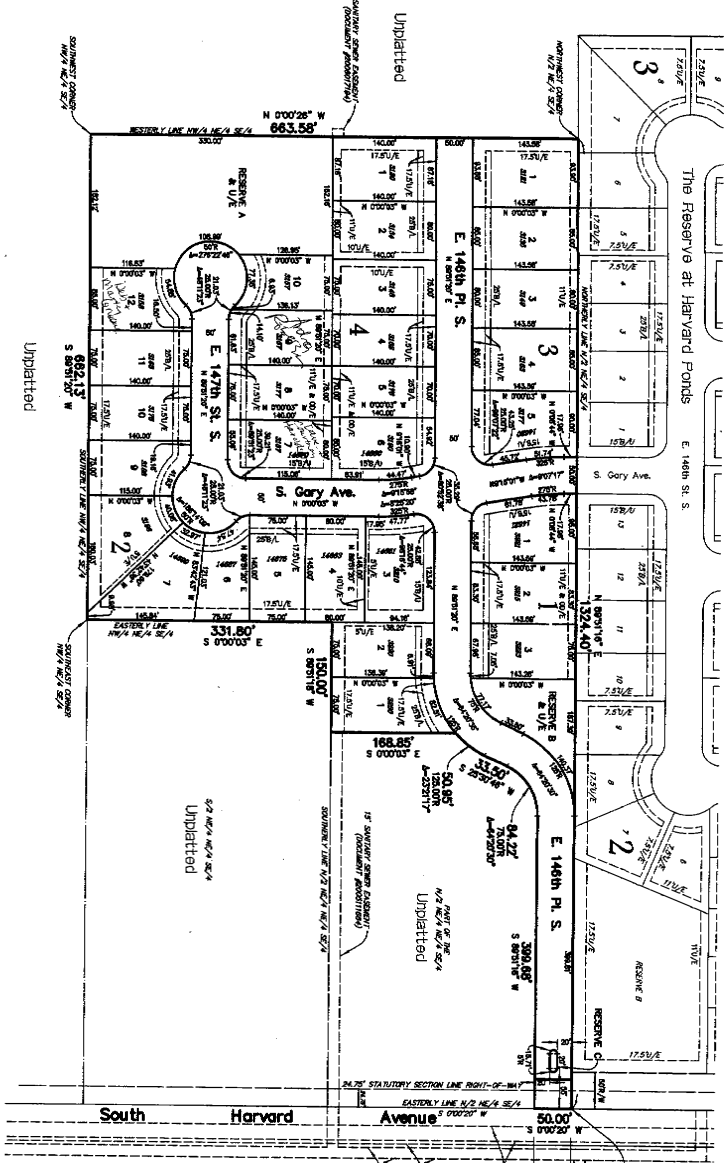
