  has a great engineer working for them to help with that. Roger Kuykendall of Gray and Osborne went over
  areas to help prevent problems.

### **UNFINISHED BUSINESS**

- Lift Station Replacements- Roger Kuykendall of Gray and Osborne went over what happens next. The
  capacity will not be increased and there will be no major modifications. Replacement of worn and
  antiquated equipment is the scope of the project. Chair McMahan advised Roger to move forward with
  project.
- Overlook Crest- Developer is having difficulties getting permits from county. Probably won't start until spring 2023. Payment of ½ of GFC fees will be due prior to construction from developer.
- Collections-
  - Commissioner Anderson is still waiting for proposal from Skagit Bonded.
  - o Proceed with Skagit Law at this time for liens/collections.
- Budget-
  - Draft budget from WWS will be out via email in a week or two.
  - Chair McMahan said to go ahead with updated comp plan.

  - Start charging late fees.
  - Update resolution. Present updated resolution at next meeting.
