



Coaching Agreement

The Client understands that although Ms. Van Wuffen is a Licensed practicing counselor, (LPC-20531, LPC,10644, LPC 99327) she is not using her license for the services rendered, she is not presenting herself as a therapist to the Neuronova clients and she is not providing psychotherapy to any Neuronova clients. Ms. Van Wuffen is a certified brain health coach and certified advanced ADHD professional. These certifications are applicable to providing appropriate coaching and consulting.

Mr. Van Wuffen, is not a licensed clinician, but a trained coach and has the qualifications to provide relational coaching for those living with ADHD.

As coaches, we are not diagnosing any mental health issues. We are neither treating any mental health illnesses that are otherwise suited for licensed therapist, psychologist, NP and psychiatric care.

Coaching also helps to facilitate personal development, professional and business goals. You agree that as mentors and coaches we are not responsible nor liable for any actions or inaction resulting from any services offered.

If you are currently in therapy and would like to add your coaching experience into the continuity of care, you are responsible for communication between you and your therapist. That means, ascertaining the appropriate releases of information.

All coaching interaction will be upheld in confidentiality. However, please be aware that the coach-client relationship is not considered a legally confidential relationship (like the medical and legal professions) and thus communications are not subject to the protection of any legally recognized privilege

Description of Coaching: Coaching is a partnership (defined as an alliance, not a legal business partnership) between the Coach and the Client. The purpose is to help the client optimize his or her own development and personal growth.

Coaching is not psychotherapy. Coaching is neither a substitute for therapy. As coaches, we will not provide any arbitration, advice regarding medical or mental health issues.

You are responsible for implementing your own mental, physical and emotional well-being. You are responsible for your own choices, actions and the results of those choices.

The client also understands that as a coach, we are still required by law as a mandated reporters. This responsibility extends to any coaching, mentoring or other types of counseling that Ms. Van Wuffen provides. Therefore, if there are reports of abuse to children or elderly (adult sexual relationships with minors) I am obligated to report.

Confidential Information does not include information that: 1. Is known generally by the public or client's industry. 2. The coach is required by lawful issued subpoena by court. 3. If there is any disclosure or reasonable belief by the coach that there is imminent danger to the client or someone the client knows (duty to warn).

Cancellation Policy: Client agrees that it is the client's responsibility to notify the coach 24 hours in advance of the scheduled calls/meetings. The coach reserves the right to bill the client for a missed meeting. Coach will attempt in good faith to reschedule the missed meeting

Termination: Either the Client or the Coach may terminate this agreement at any time. Client agrees to compensate the Coach for all coaching services rendered through and including the effective date of termination of the coaching relationship.



Schedule and Fees:

The fee is: \$150 per hour for a 7-week course.

Payment can be received by Venmo or Ivy Pay. Payments will be taken prior to each session.

The Coach will initiate all scheduled calls and will contact the client promptly at the time of the scheduled appointment. If there are any changes to the scheduled appointment, the client will be immediately contacted.

Client agrees to adhere to the work that needs to be put into the coaching process. And understands that the coach is not there to do the work for him or her.
