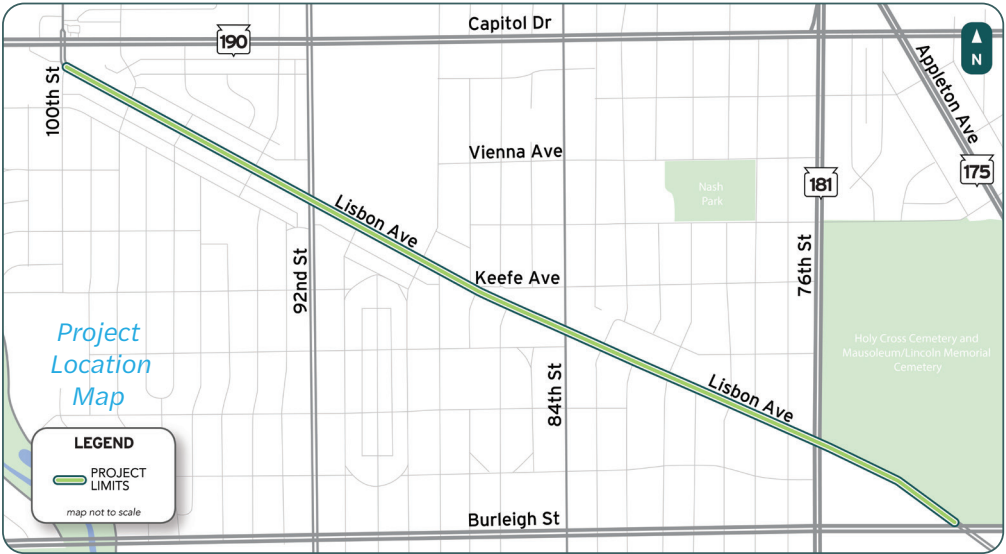

The City of Milwaukee, in partnership with the Wisconsin Department of Transportation (WisDOT), is hosting the second Public Involvement Meeting for the proposed West Lisbon Avenue reconstruction project. This meeting will be in open house format with project members available to answer questions and share project updates.

PROJECT GOALS

The project will fully reconstruct West Lisbon Avenue. The complete reconstruction of the roadway offers a good opportunity to evaluate modifications and improvements as appropriate, and the project team has been evaluating safety, operations, and multi-modal transportation needs for the corridor. Traffic analysis shows a 2-lane roadway (1-lane in each direction) meets the project goals and rebuilding as 4-lanes does not meet project goals. Therefore, the proposed alternatives shown include 1 travel lane in each direction.

MEETING PURPOSE

The City of Milwaukee, in partnership with the Wisconsin Department of Transportation (WisDOT), is proposing to improve West Lisbon Avenue, between North 100th Street and West Burleigh Street. The meeting is an opportunity for people living, working, and traveling along West Lisbon Avenue to hear about the proposed alternatives and discuss concerns along the corridor. Your input will help identify solutions to make the street safer and more enjoyable for bicyclists, pedestrians, and drivers. Here are some examples of input we are seeking from you:

- Are you able to provide the project team with any up-and-coming events?
- Where is street parking used the most along the roadway?
- What business concerns do you have during or after construction?
- What information can you share regarding, historic properties, hazardous materials, private drainpipes or tiles, private irrigation systems, and any other concerns?
- Are there problems with sightlines at intersections or driveways?

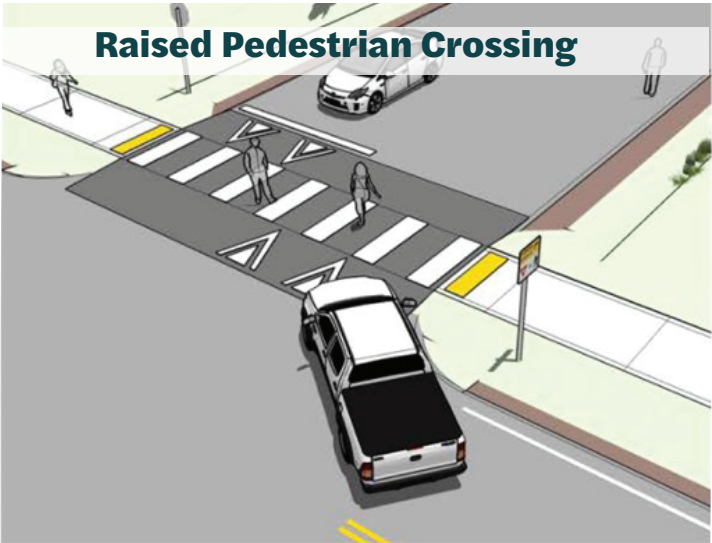
